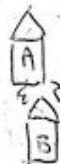
Sketch Plan

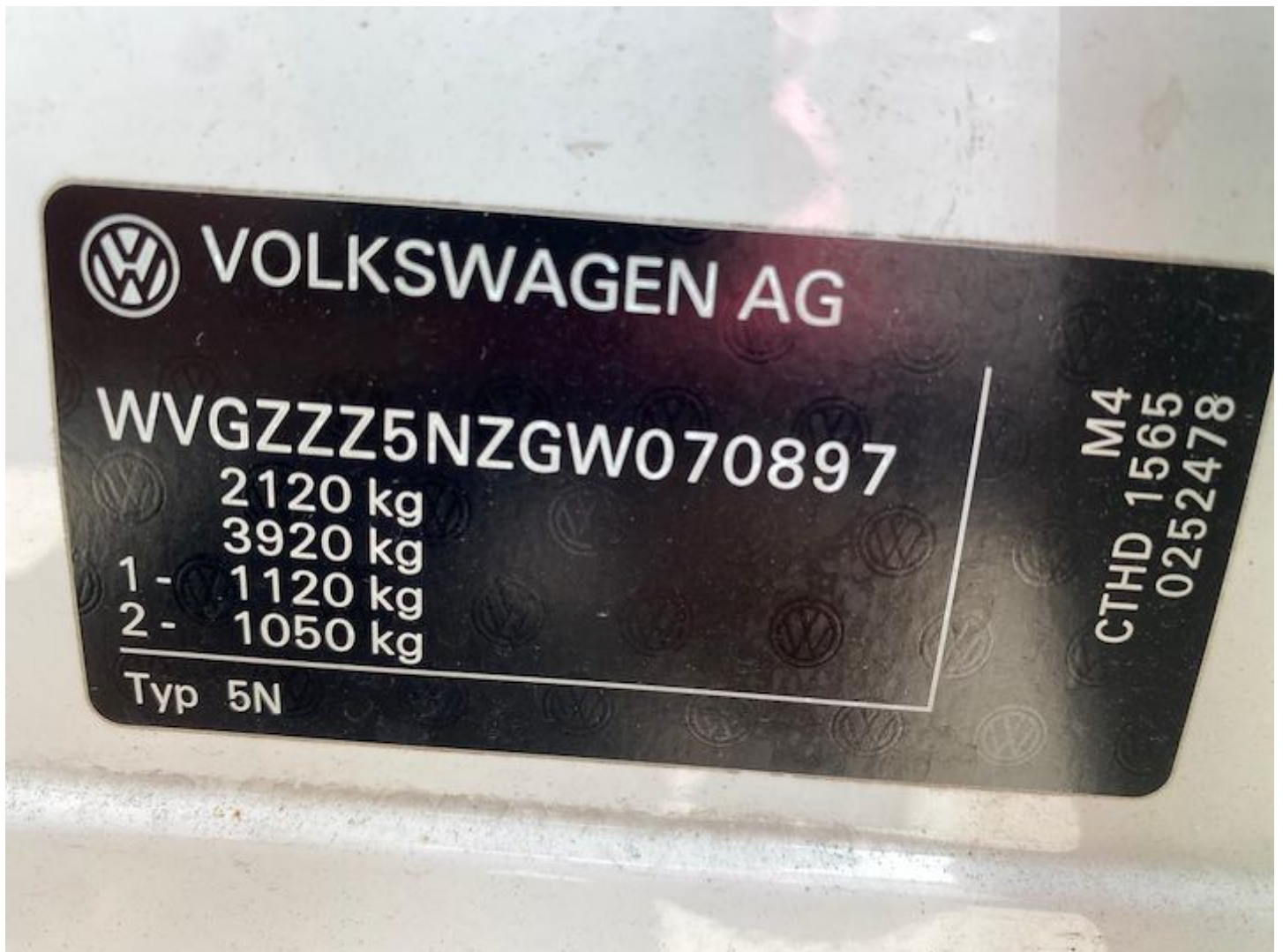

#### RENTAL AGREEMENT FOR USE OF VOLKSWAGEN TIGUAN 1.4A, SLC6622H

Automobile Tyre Pte. Ltd. (the "Owner") Co. Reg. No. 201835569R agrees to rent Vehicle No. **SLC6622H** (the "Vehicle") to **MENON ROSHAN** (the "Hirer") **FIN**, residing at **5 BLANDFORD DRIVE SINGAPORE 559799**, for the purpose of personal vehicle usage for a contract period as stated below.

The Vehicle is strictly for use in Singapore and Malaysia only.

The Hirer shall be fully liable for any and all damages incurred (including third party damages) for any accident that is unreported, or if reported, the Owner is unable to claim under its insurance policy for any reason including failure to obtain the particulars third parties involved in the accident or for use of the vehicle under the influence of drugs, narcotics, alcohol or any other substances that would impair or affect the ability of the Hirer to properly operate the vehicle.

The Hirer shall be fully liable for loss or theft, damages, traffic summons, accident claims, of the Vehicle during the Rental Period.

### Deposit

The Hirer shall, upon signing this agreement, pay the Owner a deposit amount (the "Deposit") of Singapore Dollar, Two Thousand Only (S\$2000.00) as security, which the amount shall not vary during the Rental Period. The Deposit is payable upon collection and handing over of the Vehicle.

Without prejudice to any other rights or remedies accruing to the Owner under this agreement, the Owner shall be entitled to forfeit and/or retain for the Owner's account and benefit any part of the deposit in the event of any breach by the Hirer of this agreement.

Without prejudice to any other term of the agreement, the Deposit or any part thereof may be used for the following purposes:

- (a) to offset any cost of repairs or excess payments required under the Insurance Coverage in the events of an accident, and any damage, repairs or liabilities that is not covered by the insurance coverage due to the act, omission, neglect, default or misconduct of the Hirer or the Authorised Driver;
- (b) parking charges, traffic fines, electronic pricing charges and toll fee imposed by any authority arising from the use of the Vehicle
- (c) costs of repair or cleaning of the vehicle, including costs incurring in relation to the following:
  - i. damage or cuts to the Vehicle rims or tyres;
  - ii. damage to the interior of the Vehicle (such as lamps, dashboard, seats, etc);
  - iii. damage or cracks to the Vehicle lamps or windows;
  - iv. scratches or dents to the exterior body panel of the Vehicle;
  - v. damage to the front and rear bumpers of the Vehicle (and which include costs of replacement, repair and/or spray painting); or
  - vi. heavy cleaning of the interior (for example, due to vomit, dirt and/or food spilling) or
- (d) any losses or costs accruing to the Owner if the Hirer or any Authorised Driver uses the Vehicle for any purpose for which it is not expressly designed, including driving lessons, towing, racing, pace-making, or for competing in any form of motor sport or any illegal purpose whatsoever.

Subject to the Hirer having fully discharged all his obligation under this agreement, the Deposit (or the balance thereof after any deductions and set-offs) shall be fully refunded, interest free, to the Hirer within fourteen (14) days after the expiry of the rental period.

### Insurance

The Vehicle is insured under a standard commercial motor vehicle insurance policy and in accordance to laws of Singapore against (a) all third party risks and liabilities, (b) loss or theft to the vehicle. Insurance coverage will be applicable for use of the vehicle in Singapore and Malaysia only.

The Hirer hereby assigns to the Owner any and all damage and insurance claims, which he may have in relation to the loss and damage to or in connection with the Vehicle during the rental period, and agrees that the same be paid directly to the Owner.

There is an excess for damage sustained to the Vehicle and for third party liability in the amount of S\$1,500.00 (excluding GST) and own damage liability in the amount of S\$2,000.00 (excluding GST), which shall at all times be the responsibility of the Hirer to bear. All excess conditions under the insurance coverage mutually exclusive and shall be applied separately in respect of each separate claim.

In the event of an accident, the Hirer shall:

- (a) obtain the vehicle registration numbers of the vehicles involved, the names, addresses and IC numbers of the parties involved and those witnesses to the accident, if any
- (b) not admit fault or liability
- (c) not abandon the Vehicle without ensuring adequate provision has been made to safeguarding of the Vehicle for the securing of the same, and
- (d) notify the Owner of the accident within 24 hrs of the accident occurring and assist the Owner in providing all the necessary information pertaining to the accident to the relevant insurer (if required)

The Hirer shall be required to make a police report and forward a copy of the accident report to the Owner as soon as possible if the accident involves:

- (a) a fatality
- (b) damage to government property
- (c) a foreign vehicle
- (d) a pedestrian or cyclist

- (e) a hit and run case or
- (f) injury (where at least one person involved in the accident was taken to hospital from the accident scene (whether by an ambulance or self conveyed) or any party involved in the accident was injured and obtained outpatient medical leave for three (3) days or more.

### **Maintenance, Breakdown and Emergency Services**

The Owner shall at its own cost provide servicing and maintenance to the Vehicle regularly for every 10,000 km of mileage or once every 2 months (whichever is earlier).

The cost of any other servicing of the Vehicle or replacement of tyres shall be borne by the Hirer.

No Replacement vehicle will be provided for vehicle maintenance (1 day off in lieu for servicing require more than 12hrs).

In the event of a breakdown of the Vehicle and for the period during which the Vehicle is out of commission, the Owner may at its discretion provide the Hirer with another vehicle of a similar displacement. If the Owner does not provide a Replacement vehicle during the breakdown period, the Owner shall pro-rate the Rental Fee accordingly.

### **Others**

- (a) The Owner shall not be held responsible for any loss or damage to articles stored or left in the Vehicle during the Rental Period.
- (b) The Owner shall be entitled to repossess the vehicle at the Hirer's expense at any time without giving him prior notice if upon the expiry or termination of the agreement when the Hirer did not return the Vehicle to the Owner. The steps that the Owner may take to repossess the Vehicle include, but not limited to, entering the Vehicle with its spare key, towing the Vehicle, and/or relying on third party vehicle repossession services. In the event that the Vehicle is repossessed by the Owner under this manner:
  - i. the Hirer hereby agree that the Owner will not be liable for the loss of any personal belongings of the Hirer in the course of repossession.
  - ii. the Hirer will remain liable for any damage to the Vehicle at the point of repossession.


