Brief Details.

On the above date and time mentioned, I was riding my motorcycle, JTF1275 along Tuas Crescent as I was on my way to work. It was a one lane road. As I was riding along the said road, there was another car that was trying to turn out into Tuas Crescent from one of the company's exit, believe to be The Lycra Company.

At that point of time, I did not see the car. Nor did the car see me. This was because the road that I was riding on, there was a heavy vehicle parked at the side of the road right before the entrance of the above mentioned company. Hence, due to this, it might have blocked both of our vision at that point of time.

Therefore, since I did not see her, I just rode as per normal. As I was about to pass the entrance and exit of the above mentioned company, right after passing by the parked heavy vehicle, a car, SMU327T just came out suddenly as the driver tried to make a right turn. Both of us were not able to stop in time and her car collided onto the side of my motorcycle. I then fell and sustained a few abrasions on my leg and hand.

The driver then got off and we exchanged particulars. Her name was Valerie, hp: 93667240. She then offered to send me to the nearest hospital, Ng Teng Fong General Hospital and I received a 5 day MC.
