
8. Consent under the Personal Data Protection Act (PDPA)

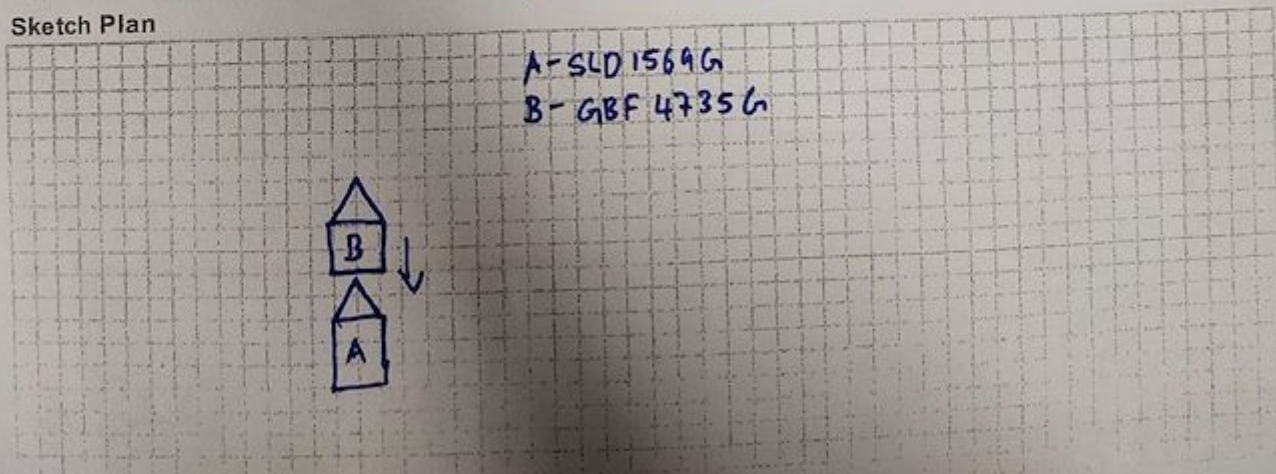

Sketch Plan




Describe Circumstances of the Accident
