

Sketch Plan





Brief Details.

On 27/05/2022, at around 5.35PM - 5.40PM, I was travelling along PIE towards Changi Airport, at the merging between PIE and TPE exit to Changi Airport. I had 4 passengers with me going to Changi Airport. There were two lanes along this road and I was on the right lane. The left lane was to exit into Changi Airport. There was another vehicle(SMG7099D) in front of me on the left lane. At first, I filtered into the left lane behind him, travelling at about 60-70km/h, subsequently, he was driving slowly and as such I decided to overtake him. I then used the right lane and overtook him. I saw that I had overtook his vehicle, and subsequently signaled to filter back into the left lane in front of the other vehicle. I then filtered into the left lane when I checked there was vehicle space. However when I entered the left lane, there was an impact to my vehicle. Both of us stopped our vehicles, and I made a check and the front right side of his vehicle had collided into the rear left side of my vehicle.

I tried to engage the other driver, however he remained in his vehicle and indicated to me he was talking on his phone, and gave me a thumbs up signal. As such I did not manage to get his details. I managed to take photos of the damages.

There was no injury to me or my passengers. No police and ambulance attended to the accident, and there was no damage to government property. I am lodging this report for record and reference purposes, for company insurance claims.
