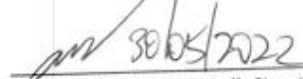

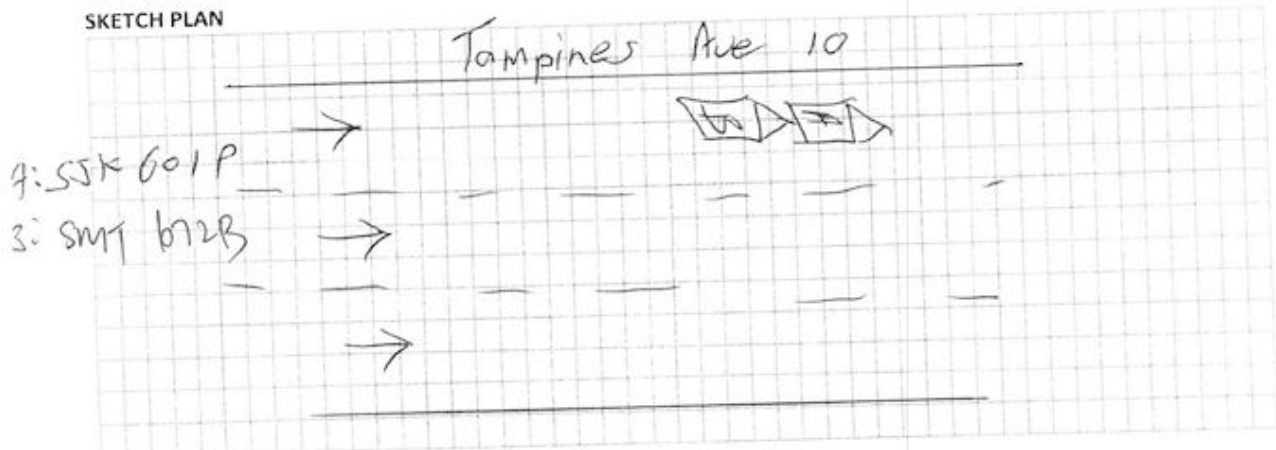

SKETCH PLAN



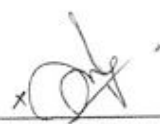
