CONTINUATION OF REPORT

Brief Details.

On 27/05/2022 at about 0824 hrs, I was waiting at Yio Chu Kang road x Munshi Abdullah Avenue junction. I was in the middle lane, positioned as the fourth vehicle. Just as the traffic light turned green, I waited for the vehicle in front of me to move off. I then suddenly heard a loud horn and then felt a huge impact from the rear of my van (GBH9169Y). I then came down from my van to check what had happened. I realized that a lorry (YN3237U) had hit the rear of my vehicle. I did not manage to exchange details with the other driver as we were all rushing off to work. However, we did take note of each other's vehicle plate number.

Upon impact, I felt pain in my neck and shoulders. I went to see a doctor after my work and after reporting to my insurance. The doctor had given me 3 days MC. I wish to inform that I went to Seng Kang General Hospital.
