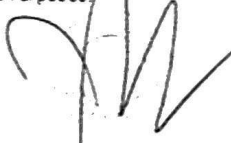

Sketch Plan

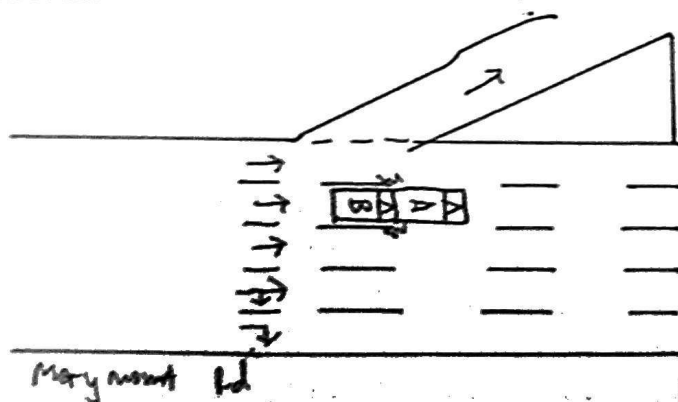
