Brief Details.

On 25/04/2022, at about 1549hrs, I was on my way to pick up one passenger at Bukit Merah Central Entrance, Connection One Pickup point which is at Connection One Tower 5. I travelled from Henderson road and turned right into Bukit Merah central, as I was arriving at the drop off point, I stopped my vehicle and checked my blind spot and ensured that it was clear before moving on. As I was turning into the pickup point, a motorcycle bearing the number plate (FBQ2521L) suddenly hit my vehicle (SLL2615H) front passenger side and I stopped me vehicle immediately. I noticed that the rider of the motorcycle had fell down and he was assisted by the member of the public. I then told one of the member of public to call for an ambulance. I am certain that I did check before turning into the pickup point and I was not speeding.

As we were waiting for the ambulance, one of the member of public was administering first aid on the rider. Shortly, ambulance and the Traffic Police had arrived. I was interviewed by the Traffic Police officer (SSS Justin) and the SD card of my car cam was handed over to him.
