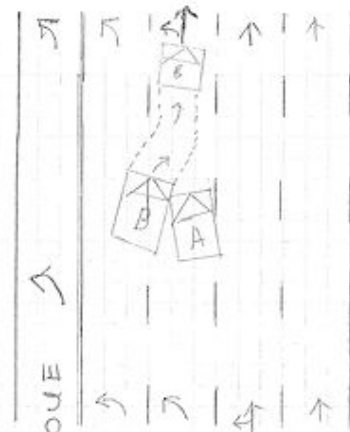

Describe Circumstances of the Accident

On 31/5/2022 at about 0845 hours, the weather condition is clear and road surface is dry. I was travelling along Collier Quay towards Rattles Quay. Collier Quay is five lane Road and I was travelling along the middle lane. Suddenly car B (SDJ 218P) from my left side who was travelling along second lane from left change lane into middle lane, car B encroached into my lane and collided into my car front left portion. I brake immediately to avoid collision, however car B (SDJ 218P) unable to stop in time and causing long hair line scratches over the car right side.
