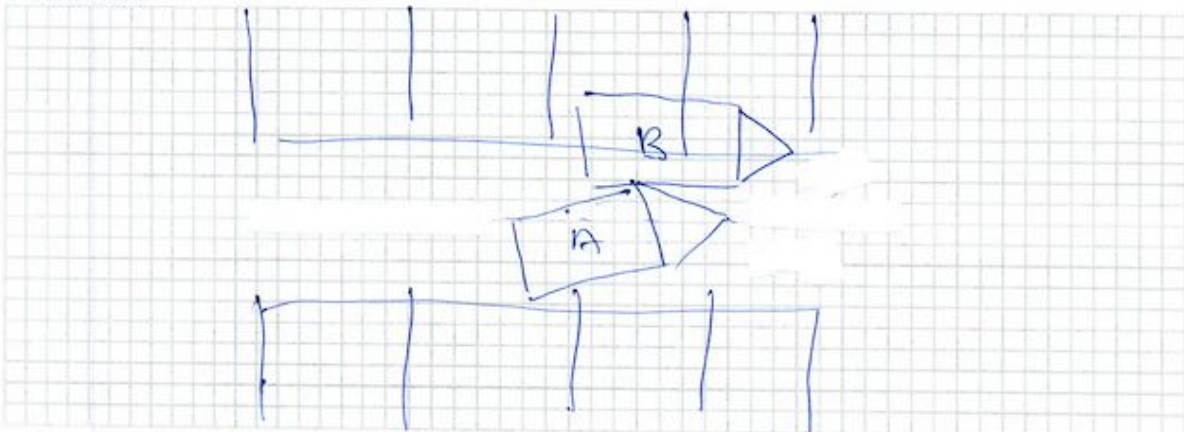

Circumstances

I was moving into the carpark where there were parking lots at two sides of the road. I wanted to park the lot on my left and I moved slowly to the center lane to position my car to reverse into the lot.

I checked all views before I moved closer to the opposite lane in case there is any incoming car coming at that direction. There was no car seen and I proceeded to reverse.

To signal my intention park, my hazard light was turned on as I was moving into the center lane and then reversing into the lot. Please refer to the footage of my front dash cam and you can see the lights on the floor.

As I was reversing, the 3rd party driver drove past the side and scratched the bottom front left of the car. Although he is on the right way of lane, however:

1. As I was already mid lane, there will be no space to overtake me. You can see that the driver drove to the side of the empty parking lots to attempt the overtake (which is wrong).
2. I slowed down and turned on the hazard light to signal my intention to park. He should have stopped and not risk/attempt to drive past the narrow space to overtake which resulted in this minor accident.

In my car, there was my helper, my mother and my 3 year old child. Although there was no injuries however, I'm having anxiety from driving and my daughter was affected by the accident (had nightmares). Note that my father (carrying my 10month old daughter) coincidentally happened to be walking at the side of the road and at close proximity to the location. He witnessed the car driving pretty fast to overtake me and I cannot imagine if he was at the empty carpark lots which the driver had wrongfully taken advantage of to overtake.

With the above justification, appreciate your consideration on this case.
