





Brief Details.

On 27/05/2022 at about 1815hrs, I was riding motorbike FBN8701K along the bus lane of Hougang Avenue 3. I was turning left into Blk 247-254 Hougang Avenue 3, suddenly a car SKS3632B came from my right. As I do not have enough time to react, I collided on the front bumper of the car and I fell on the ground.

I had some abrasion on my right heel and right shin. I can feel some pain on my right thigh and left ankle.

The driver of SKS3632B was observed to be fine. No police or ambulance were at scene.

The right fairing of the motorbike was damaged. The front fairing of the motorbike sustained cracks and scratches. There were some scratches on the left fairing.

The car SKS3632B front bumper sustained some cracks.

On 28/05/2022, I went to see the doctor and I was given 3 days of medical leave from 28/05/2022 to 30/05/2022.

I wish to state that there were no in-car camera on the motorbike.
