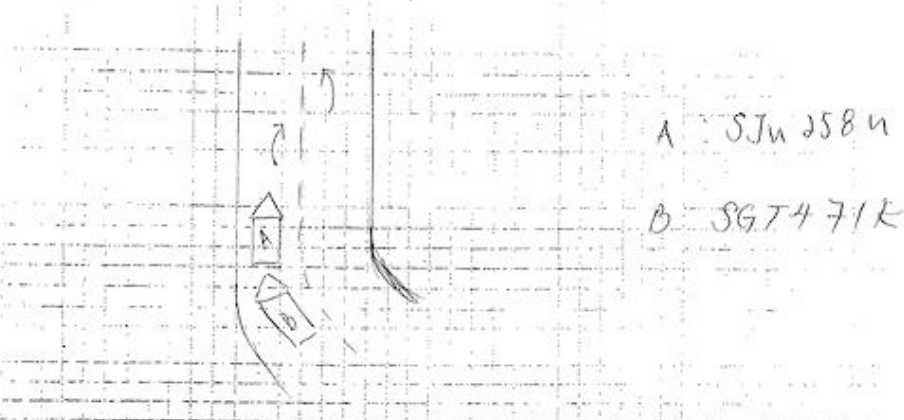

SKETCH PLAN



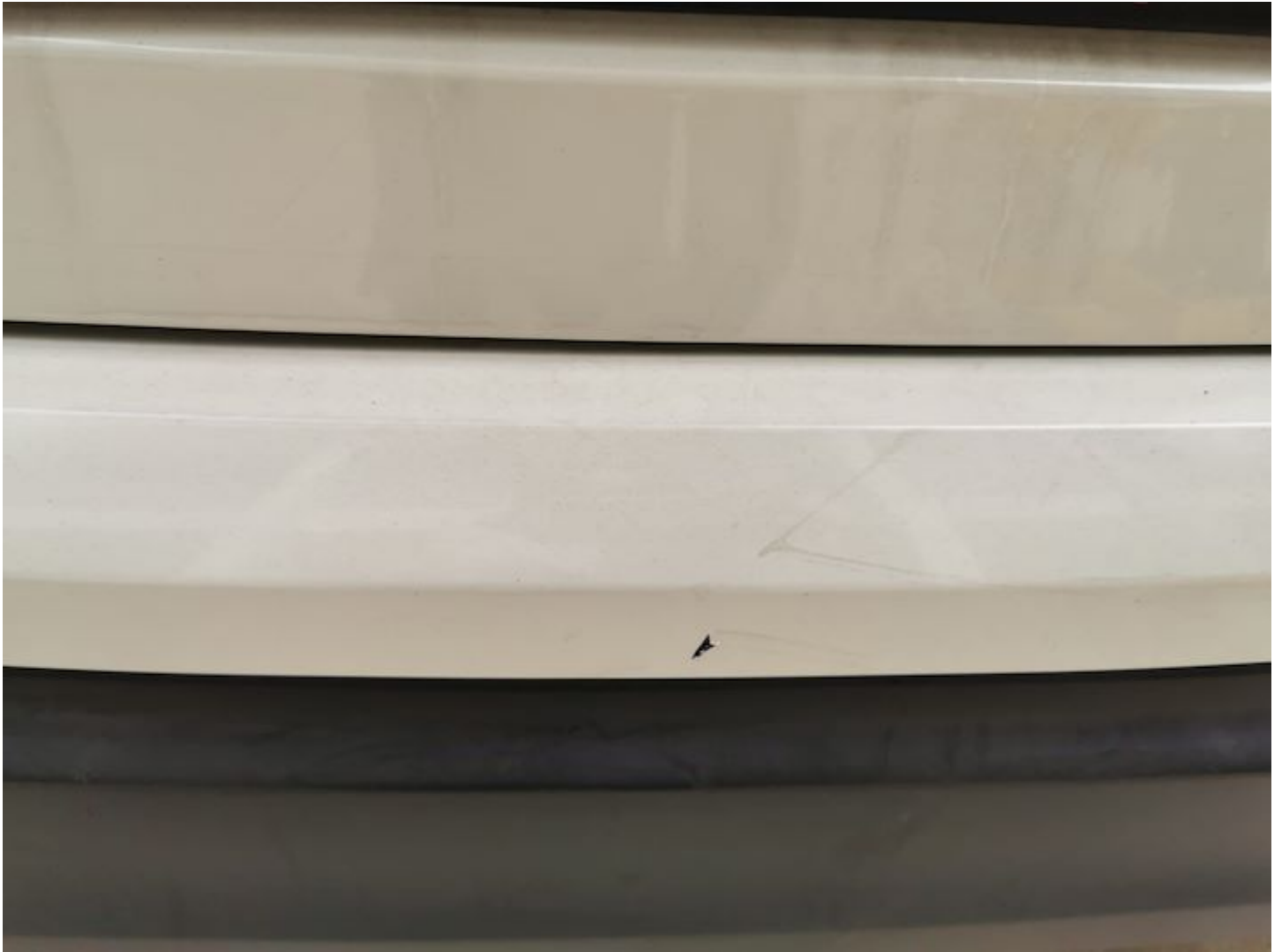
