# **SKETCH PLAN**

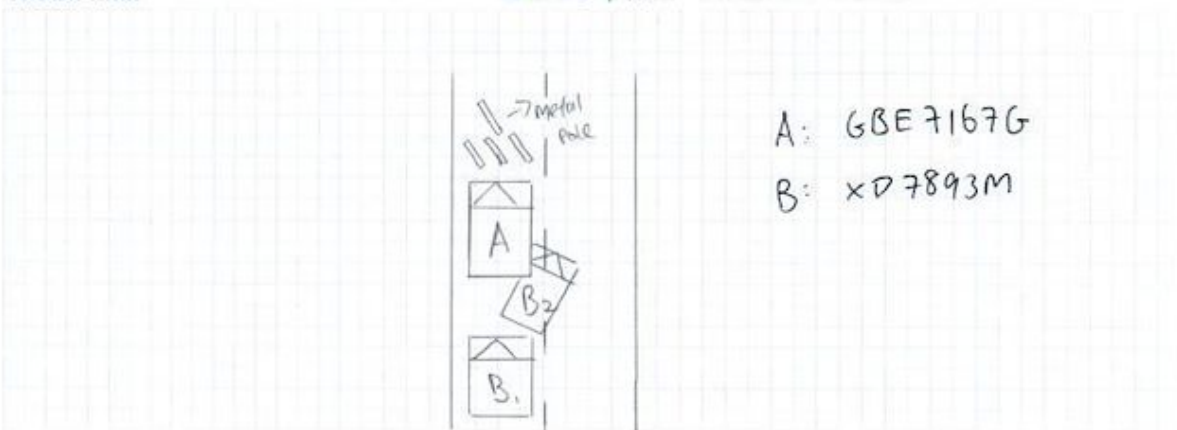
