Brief Details.

On 04/06/2022 at about 2021hrs, I picked my wife after she finished work at Studio M Hotel located 3 Nanson Road and was driving Orchard Boulevard and heading towards PIE, Steven Road. When I was driving my vehicle (SJZ4272A) along Orchard Boulevard, there was this taxi from Comfort Delgro (Plate number: SHD3844X) who was driving on the left side of my lane.

Suddenly, the taxi driver shifted lane into my lane as the driver wanted to make an illegal right turn towards ION pickup point. As the vehicle was too close to my car, I high beamed to the driver, but he ignored and continued driving to make that illegal right turn.

I made an emergency brake however my front right vehicle hit onto the taxi's right rear right causes some minor scratches to the taxi and severed scratches to my car. The emergency brake caused some discomfort to my wife as well.

After this accident, the driver quickly shifted his vehicle to the front. Then, I asked him why he shifted the car, but he did not answer my question. When asked why he made illegal right turn, the driver said he had already signaled. However, he did not check his safety and instantly make that illegal right turn without giving some time for me to slow down.

The driver was driving on the straight lane only however he made an illegal right turn as he wanted to make that right turn towards ION pick up point. Afterwards, I exchanged particulars with the taxi driver and parted ways right after and we will be settling through our own insurance company.
