**Brief Details.**

I am FBB9331B and I was riding at about 20km/h along Jalan Bukit Merah towards Alexandra Rd on the second lane. As I was near the junction of Jalan Bukit Merah and Jalan Kilang Barat, a taxi had quickly make a right turn from Jalan Bukit Merah (towards Henderson) into Jalan Kilang Barat even though I had the right of way. The taxi passed by in front of me and the third party van GBH1450L followed the taxi without checking for incoming vehicle. I was already inside the yellow box and GBH1450L then collided into the front right of my vehicle. I flung for about 5metres forward from the second lane to the third lane. I laid down on the ground and moments later some SCDF officers carried me to the pavement. Ambulance later arrived and I was conveyed to NUH. I received 5 days MC and was discharged on the same day of the accident. My motorbike is damaged. The said vehicle GBH1450L front is dented and bumper came off.
