PLEASE REFER TO POLICE REPORT NO, T/20220603/2117 LODGE AT TAMPINES NPC ON THE 02/06/22 AT ABOUT 2227HRS, MY VEHICLE SMA6283B A ESTORIL BLUE BMW 428I WAS INVOLVED IN A HIT AND RUN ACCIDENT. I PARKED MY VEHICLE AT THE OPEN CARPARK (TMT32/33) NEAR THE LIFT LOBBY OF BLOCK 272 TAMPINES ST 22. I HAVE AN INBUILT CAR CAMERA WHICH CAPTURED THE INCIDENT. FROM THE FOOTAGE, THERE WAS A WHITE HONDA VEZZEL, SLU1225J WHO PARKED BESIDE MY VEHICLE ON THE LEFT. WHEN HE CAME TO THE VEHICLE TO MOVE OFF, HE WANTED TO MAKE A RIGHT TURN BUT HIS VEHICLE COLLIDED ONTO THE LEFT PORTION OF MY FRONT BUMPER. HE THEN REVERSED HIS VEHICLE WHICH THEN COLLIDED ONTO MY BUMPER AGAIN AND SUBSEQUENTLY LEFT THE PLACE WITHOUT LEAVING A NOTE. DAMAGES TO MY VEHICLE ARE DENTS, SCRATCHES TO THE LEFT FRONT BUMPER. **Brief Details.**

On the 02/06/22 at about 2227hrs, my vehicle, SMA6283B, a estoril blue BMW 428i was involved in a hit and run incident. I parked my vehicle at the open carpark(TMT32/33) near the lift lobby of block 272 Tampines St 22. I have an inbuilt car camera which captured the incident. From the footage, there was a white Honda Vezzel, SLU1225J who parked beside my vehicle on the left. When he came back to the vehicle to move off, he wanted to make a right turn but his vehicle collided onto the left portion of my front bumper. He then reversed his vehicle which then collided onto my bumper again and subsequently left the place without leaving a note.

Damages to my vehicle are dents, scratches to the left portion of the front bumper. There are also white paint marks seen at the damaged area. My inbuilt car camera also stated that there was an impact at the said time of incident. I have the footage available on thumbdrive which I can provide to the traffic police.
