#### CIRCUMSTANCES OF ACCIDENT

ON 4/6/2022 AT AROUND 2100HRS, I RETURNED TO MY CAR A THE PARKING LOT OF CHANGI BUSINESS PARK AND DISCOVERED SCRATCH MARKS AND DENTS ON THE LEFT SIDE FRONT BUMPER OF MY VEHICLE. INITIALLY I ASSUMED THAT THE ACCIDENT HAPPENED EARLIER THE SAME DAY. HOWEVER, AFTER MAKING A CHECK ON THE CCTV FOOTAGE FROM MY IN-CAR CAMERA, I DISCOVERED THAT THE ACCIDENT TOOK PLACE ON 3/6/2022 AT AROUND 2339HRS WHEN I PARKED MY VEHICLE AT THE OPEN CARPARK OF FUSIONOPOLIS, NEXT TO TIMBRE+ (ONE NORTH). THE CAMERA FOOTAGE SHOWED THAT A CAR BEARING REGISTRATION PLATE NUMBER, SMV4535C, WAS SOMEWHERE IN FRONT OF MY VEHICLE ON THE LEFT SIDE. HIS PLATE NUMBER WAS FULLY CAPTURED ON THE RECORDING. THE DRIVER APPEARED TO BE MOVING FORWARD AND REVERSING AS IF LOOKING FOR A LOT AND EVENTUALLY HE REVERSED A LITTLE TOO MUCH AND HIT ONTO THE FRONT LEFT SIDE OF MY CAR. THE DRIVER DID NOT GET OUT OF THE VEHICLE AND JUST DROVE OFF WITHOUT LEAVING A NOTE CONTAINING HIS PARTICULARS.

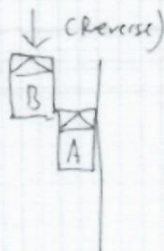
