

Brief Details.

Our Ref: TP/IP/14252/2022

On 5 June 2022, I drove from Tiong Bahru Hawker Centre after lunch to home via Lower Delta Road. When it was red light at traffic junction between Lower Delta Road and Jalan Bukit Merah, I stopped the car. When the traffic light turned green, I started to drive straight towards Lower Delta Road, on the second lane from the left. I drove along cautiously as traffic in front was heavy and there was a slip road on the left for vehicles to filter onto Lower Delta Road. Suddenly, a lime green car cut across from the left to the front of my car. I had to apply emergency break to avoid colliding into it. I gave my car horn a long burst. The car in front applied its break and as it was about to move off, I horned at it again because I was upset that the driver had driven in a reckless and dangerous manner. There was no contact or sound of impact between the front of my vehicle and the back of the lime green car. The section of the road or thereabout where I had to apply emergency break is where the slip road on the left join onto Lower Delta Road (see exhibit A), and my car was on the second lane from the left. After the lime green car had moved on, I saw it filter to the left side of the road and parked his car. I drove on straight, filtering to the right for my journey home via AYE. My wife was on the front passenger seat next to me. On 13 June 2022, I received a letter from Traffic Police. I drove my car to Citreon workshop seeking assistance to help retrieve the video footage from the dashcam. Unfortunately, we are unable to retrieve any useable footage as the recording has been overwritten by subsequent recording. On inspection of my car at the workshop, we noticed faint lime green paint marks on the left side of my car just above the front left tyre area (see photo attached). From the photo, it is evident that my car has been sideswiped from the left before the lime green vehicle intruded onto my lane. Please contact me for photos of both front and right side of my vehicle for your inspection. Lastly I would like to emphasize that there was no impact between the front of my vehicle and the back of the lime green vehicle. Also, I did not notice the faint lime green paint on the front left side of my car above the tyre until inspection at Citreon on 13 June 2022, after receiving the traffic police letter. Thank you.
