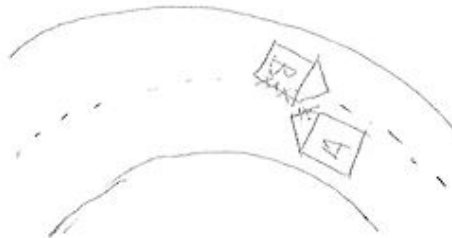

B: SLJ1742R

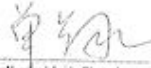
DESCRIBE CIRCUMSTANCES OF THE ACCIDENT
