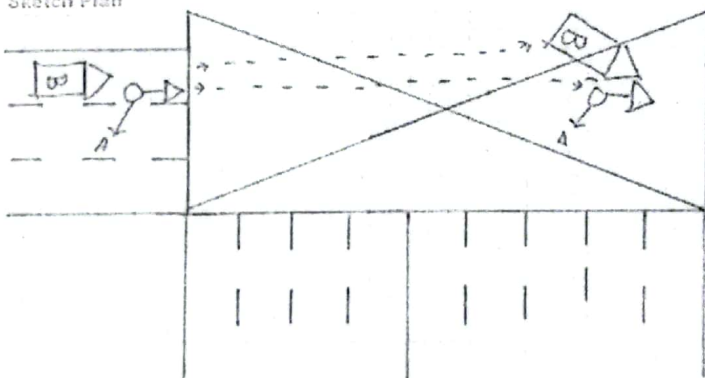

Brief Details.

On 22/05/2022 at about 10.30am, I was travelling along the middle lane of Bukit Timah Rd towards Stevens Rd with my motorcycle, FBT2007P. A SMRT bus, SMB3607R suddenly made a lane changed from the left lane and into my lane. The said bus then side swiped my motorcycle and caused me to fall from my motorcycle. After my head hit the ground, I went blank and could not remember much. The next thing I remember was that I was conveyed into the ambulance.

Due to the accident, I fractured two of my ribs, the bone joint to my right thumb and my left leg area. I also sprained my left ankle. Some other injuries were mostly abrasions. I was given 42 days of medical leaves.
