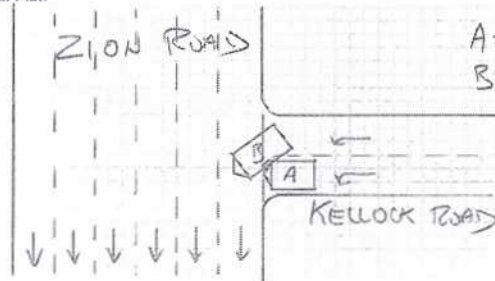

Brief Details.

On 15 June 2022 at about 12.20pm, I was driving my vehicle SJT6221R with my friend (Mr Tan Wei Tat) along Kellock Road towards T-Junction Zion Road. This is a 2 lane road, one way, both lanes are for Left Turning onto Zion Road.

I kept onto the Left Lane and stopped at my stop line to wait for traffic to clear up. Vehicle YQ2760R was on the Right Lane. YQ2760R proceeded to turn onto Zion Road, but make the turn too sharp and encroached onto my lane and collided onto the front left side of my vehicle.

This impact caused my whole car to shake and dislodged my whole front bumper out of my vehicle. My friend and I took a while to compose ourselves. We exchanged particulars and I have to call and wait for towing.
