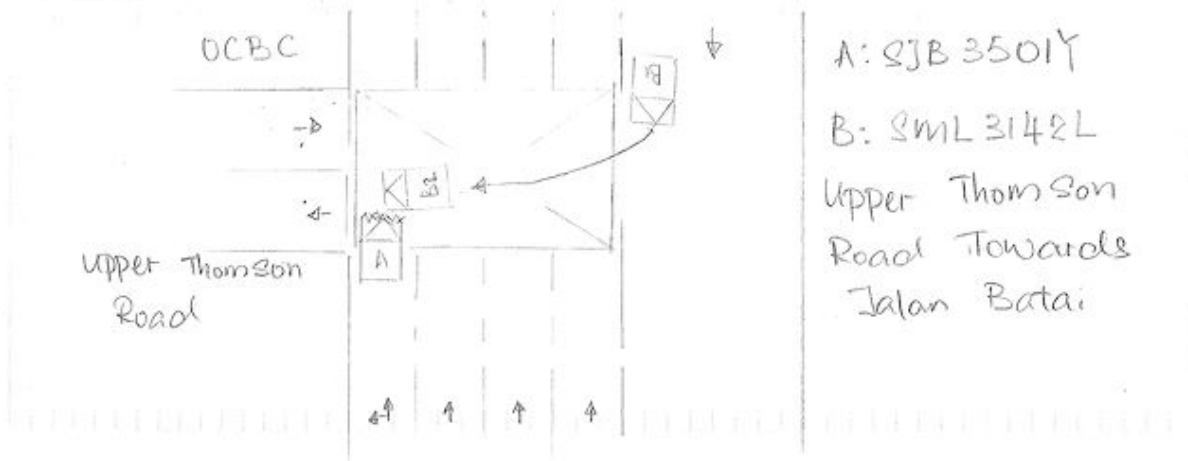

### Sketch Plan




**DESCRIBE CIRCUMSTANCES OF THE ACCIDENT**

As traffic was green light in my favor, I proceed straight , Veh B from the opposite direction make a right turn and thus collided onto the front portion of my vehicle.


Both of us alighted, we exchange particular and leave the scene.



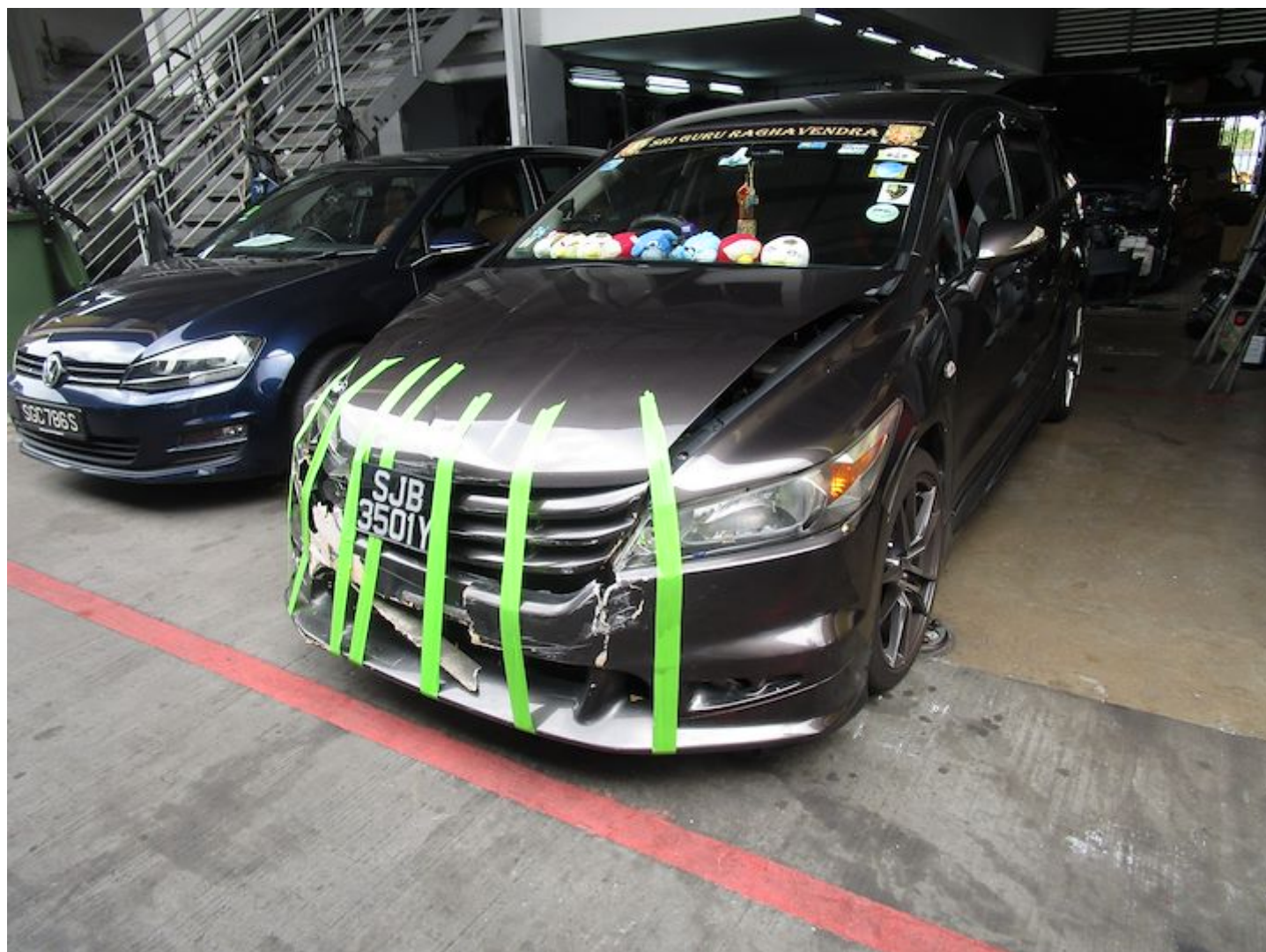

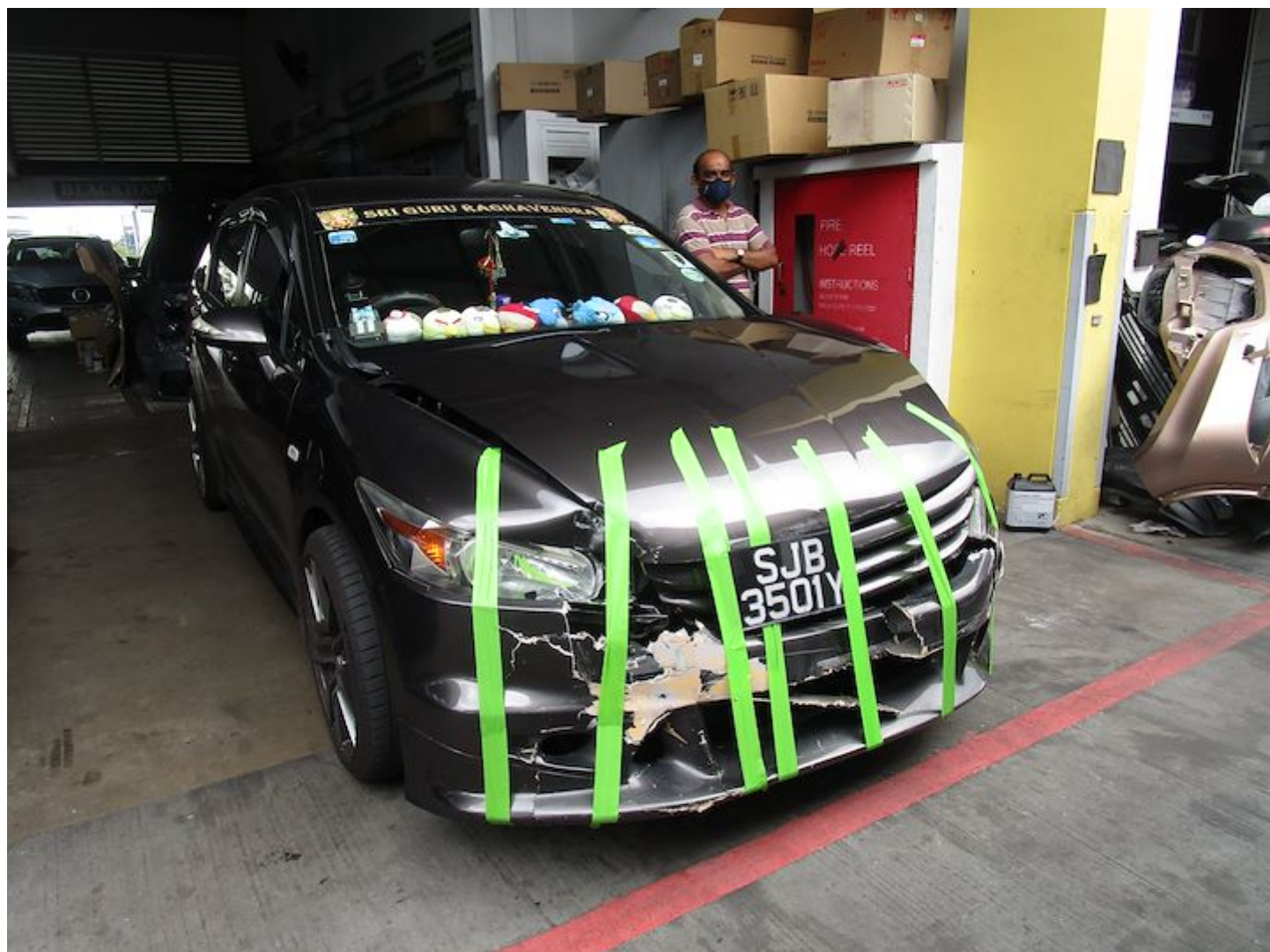
