- Possess a foreign driving licence and *International Driving Permit (IDP) issued by an authorised body from your country of origin; or
- **Possess an official translation of your foreign driving licence in ^English if an IDP is not available.**

However, if you are a foreigner from an ASEAN member state, you do not need an IDP. Please ensure you have a valid foreign driving licence.

If you already possess a valid Singapore Driving Licence and need an IDP, you may apply for one at the **Automobile Association of Singapore.*

^You may obtain a translation from the relevant Embassy, High Commission, or any local registered translation companies in Singapore if your Embassy or High Commission does not provide the service.
