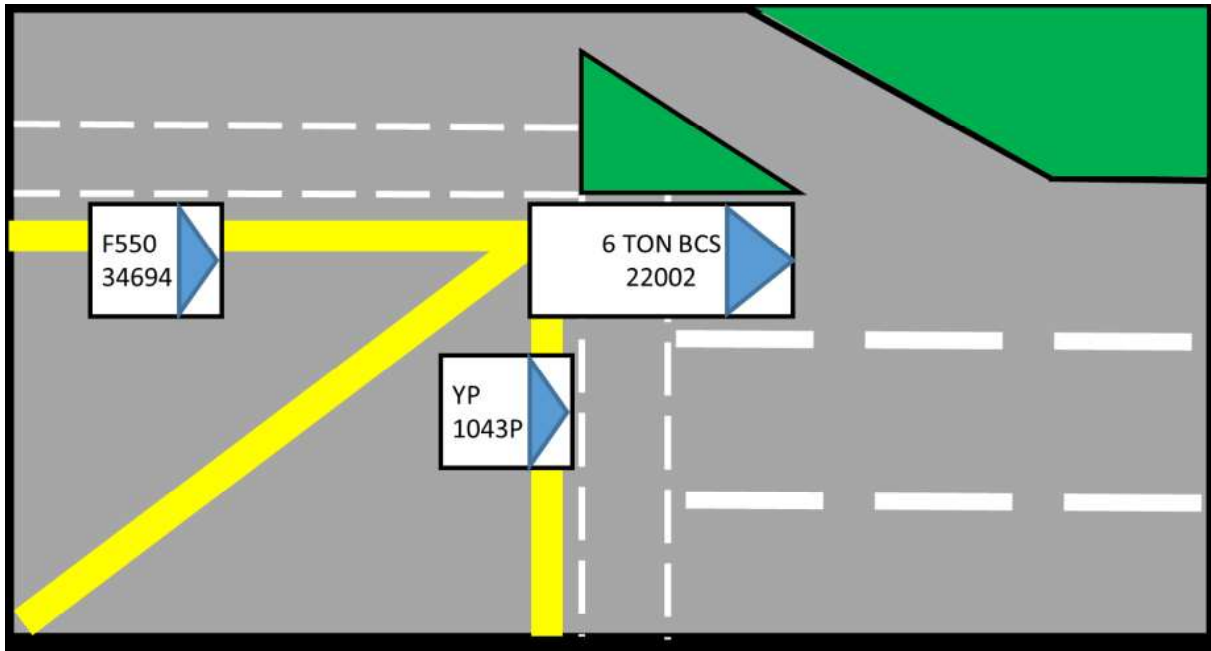


Figure 2A - Schematic Diagram Part 1

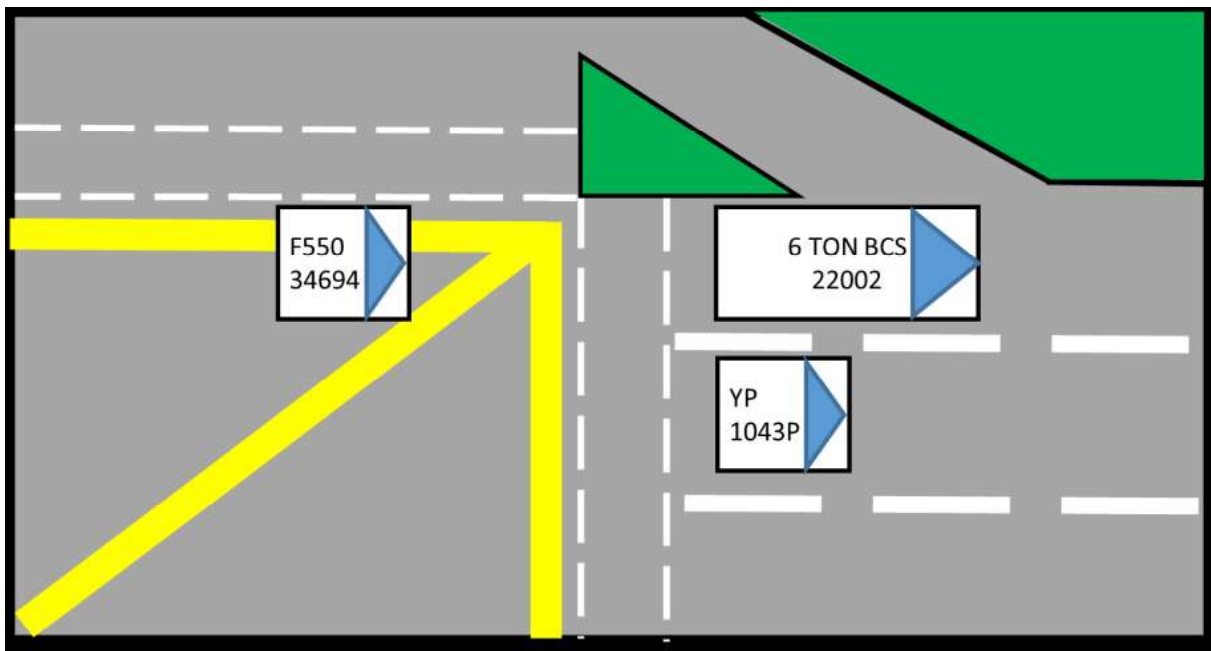


Figure 2B – Schematic Diagram Part 2

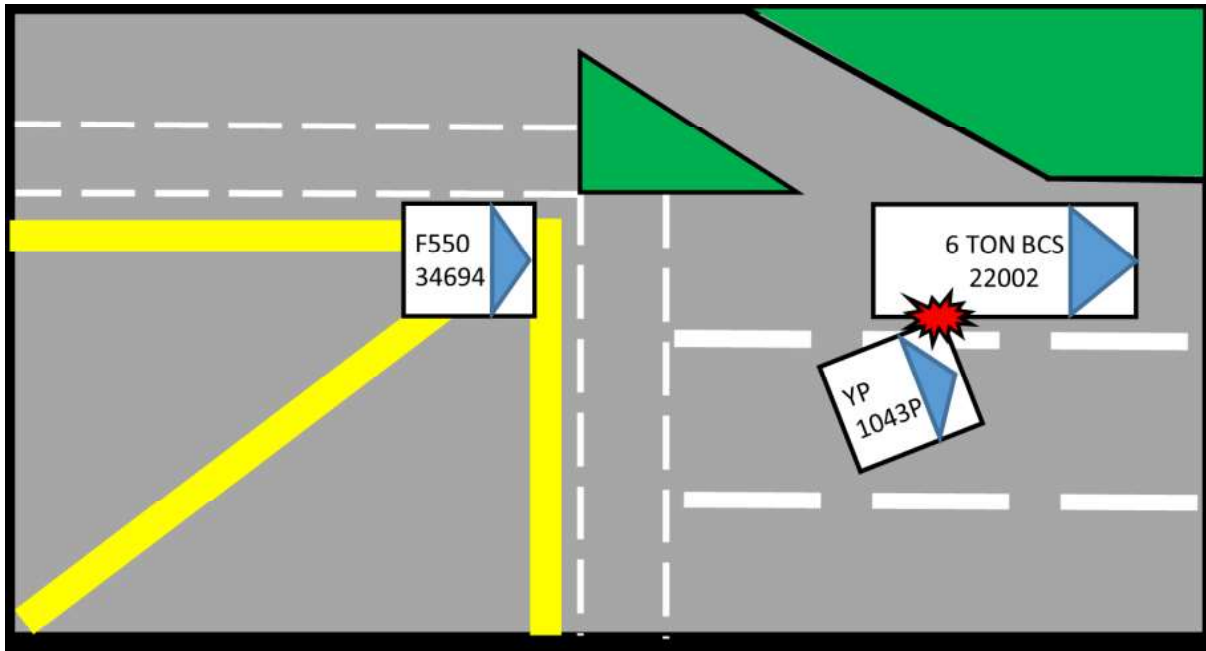


Figure 2C – Schematic Diagram Part 3
