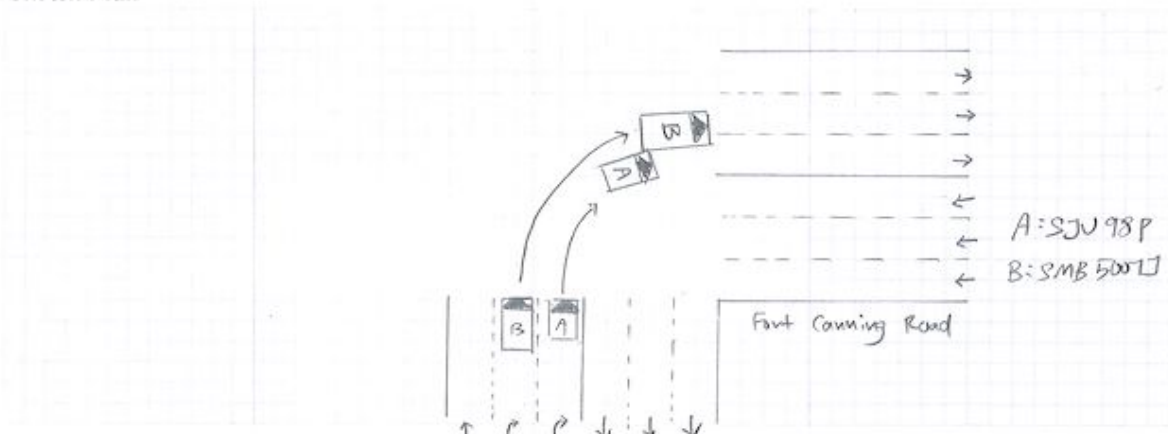

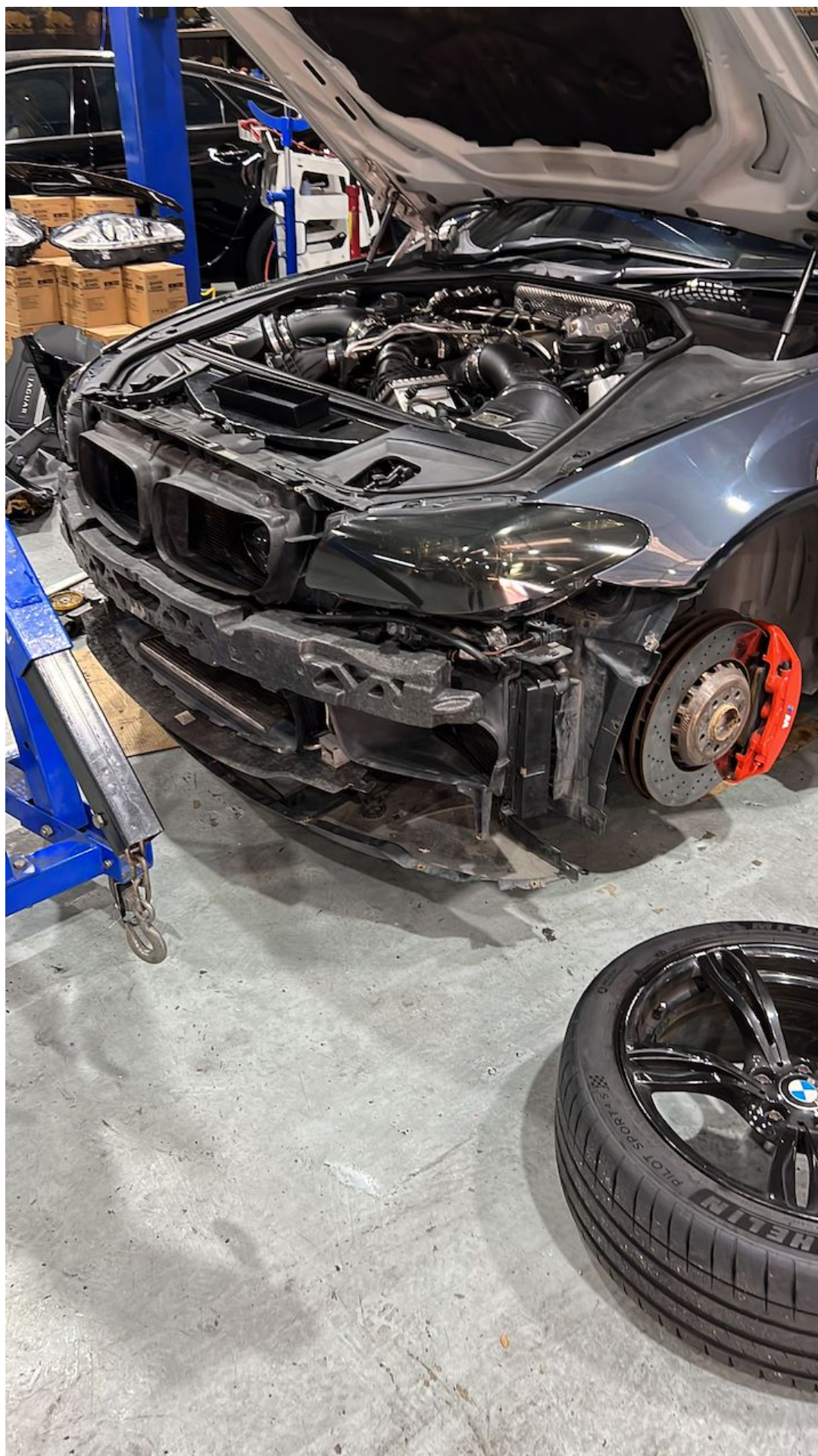
Sketch Plan
