TERMS & CONDITIONS:

(a) Return of Vehicle to Lessor

The Hirer hereby agrees to return said vehicle to the Lessor at the above address no later than the agreed date of returning.

(b) Collision Damage Waiver (CDW) insurance

All our vehicles are covered under comprehensive insurance / Fire and Theft with an excess liability. Excess liability will be imposed by the Insurer. Customers are to make payment of S\$3500 excess liability upon any accident in Singapore. This amount will be refunded once it is ascertained by the Insurance Coy that the customer did not cause the accident.

Excess Liability may be reduced by payment of the CDW insurance:-

(c) Malaysia usage (NOT FOR USE IN MALAYSIA) -

All our vehicles can be driven to Malaysia with a deposit of \$500 and an additional surcharge of S\$30 per day subjected to GST. The excess for Malaysia-use vehicle is S\$5,000 as reflected in Clause 5 of page 3.

In any case the hirer drives the car to Malaysia without prior consent, he/she will be charged \$1000 or more as a penalty

(d) Hirer/ Driver requirements:

Hirer and any additional driver have to:-

- Be 23 years old and above with at least 2 years of driving experience.
- Posses a valid Singapore class 3 driving license or a valid International driving license.

Hirer and any additional driver have to produce Singapore identity card (IC) and driving license or foreign passport and international driving license at time of hire.

(e) Petrol:

Upon returning of the vehicle, hirer should refill the petrol back to the same level as per given. Additional service charge of excluding petrol will be imposed.

(f) Mileage:

Mileage is limited to 200km (waived) per day for solely Singapore drive and unlimited for Malaysia drive.

(g) GPS navigator

GPS navigator is available for rent at \$5 per day.

(h) Child Seat

Child seat is available for rent at \$5 per day.

(i) Collection and returning of vehicle:

Hirer may collect the vehicle from our office anytime during our operating hours:-

o Weekdays - from 9am to 6pm

Saturdays - from 9am to 5pm

Sundays & PH - closed

- Any location except airport \$30 per trip subjected to GST.
- Airport \$50 per trip subjected to GST
- o surcharge applies after operating hours

Time of return shall be the same as per collection time

(j) Standard Rental Agreement

All customers have to visit our office personally to complete a standard rental agreement, whereby the customer will enter into the agreement as the hirer.

(k) Availability

All rentals are subject to availability. In the event that a booking deposit has been placed and the vehicle cannot be produced at the time of collection, the hirer shall be assigned with another vehicle of similar capacity until the reserved vehicle is available for swooping.

(I) Payment Mode

All rates quoted are in Singapore currency. Full amount is payable upon collection of vehicle by cash only.

(m) Penalty

Fines or Traffic Offenses

Any fines or traffic offenses will be paid by hirer during hire period. Remember to place your parking coupons and cash card (within the CBD/ERP or parking areas).

Traffic Violations & Offences

All traffic violations and offences committed during the rental of the vehicle shall deem to be the responsibility of the Hirer.

Insurance

All vehicles are insured. Hirer must pay excess in full amount in any case of an accident. In any case where the hirer needs to claim 3rd party insurance, the hirer still needs to pay the excess in full before payout from the insurance if any. The Hirer hereby agrees that s/he shall fully indemnify the Lessor for any and all loss of or damage to the vehicle or equipment during the term of this Agreement whether caused by collision, fire, flood, vandalism, theft or any other cause, except that which shall be determined to be caused by a fault or defect of the vehicle or equipment.

The Hirer agrees

- that the rented vehicle shall not be used to carry passengers or property for hire;
- that the rented vehicle shall not be used to carry passengers other than in the interior or cab of the vehicle;
- (c) that the rented vehicle shall not be used to carry passengers in excess of the capacity thereof;
- (d) not to use the vehicle to push, propel or two another vehicle, trailer or any other thing without the written permission of the owner;
- (e) not to use the vehicle for any race or competition;
- (f) not to use the vehicle for any illegal purpose;
- (g) not to operate the vehicle in a negligent manner;
- (h) not to permit the vehicle to be operated by any other person without the written permission of the Lessor; and
- not to carry passengers, property or materials in excess of the rated weight carrying capacity of the vehicle.
