CIRCUMSTANCES OF ACCIDENT

BC Tang was driving off-service [SBS6560L] on the above-mentioned date & time. While travelling on the 2nd lane of a 4-lane road along Loyang Ave, a red Ssanyong [SLU9836T] travelling on the extreme left turn-only lane encroached abruptly & collided onto SBS6560L causing BC Tang to swerved right & side swept against a stationary green Mitsubishi Fuso [XE9333U] on the adjacent lane. SLU9836T's driver fled the scene without exchanging particulars.

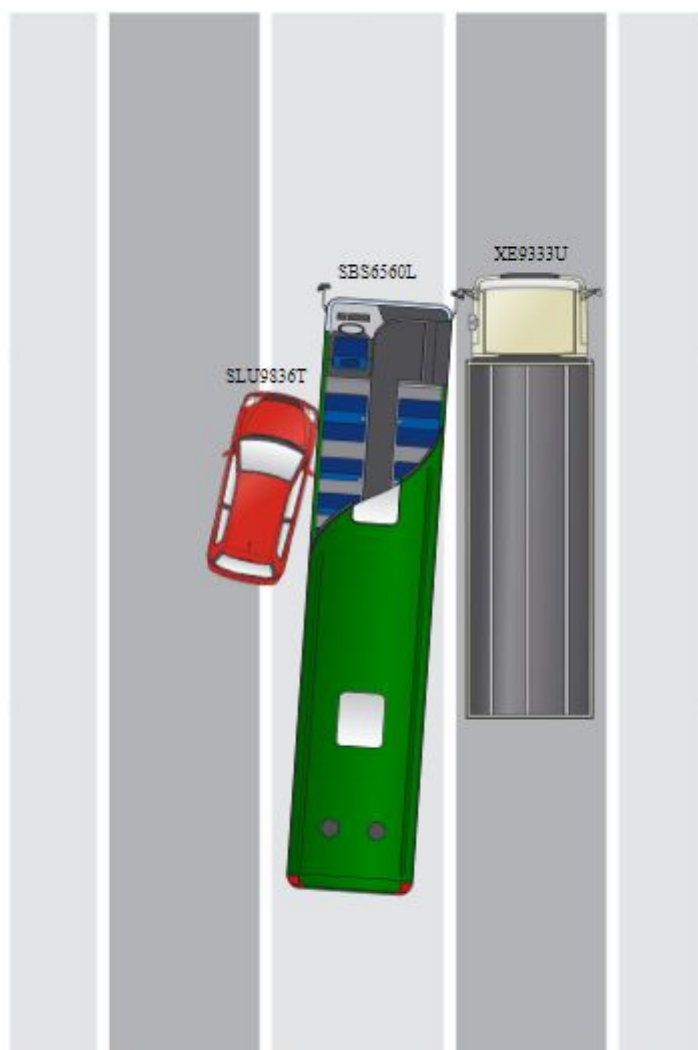
