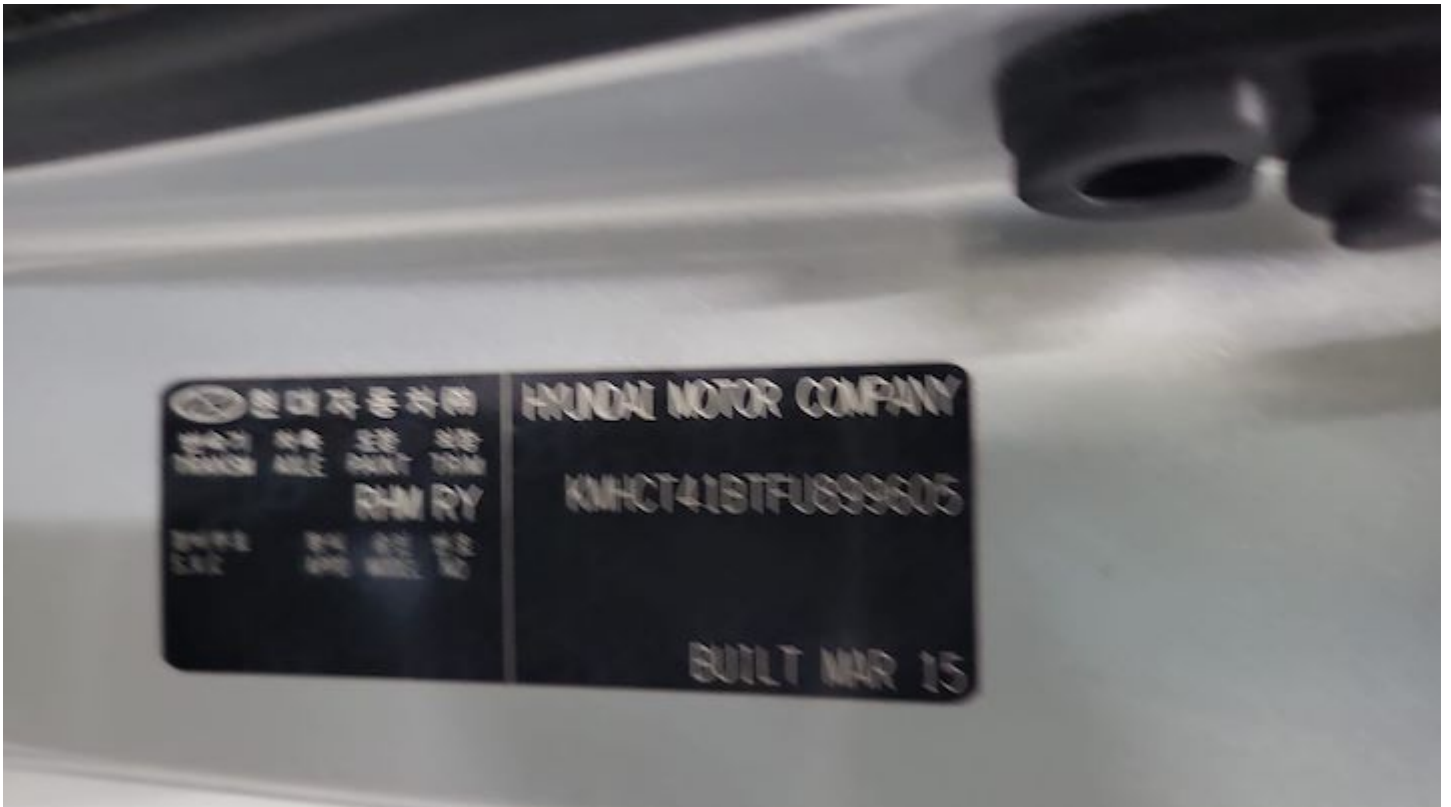

The traffic light was green for the driver, which is clearly shown in the video recording. However, there was a van on my right which came to a stop as he wants to turn right. across and I hit my brakes hard. Unfortunately, my vehicle had come in contact with him causing him to fall on his right. I came down to assess his condition and my vehicle. Passer-by dialled the emergency number and alerted the police. He was injured and my vehicle had sustained the following damage, front bumper cracked and bonnet dented. Soon, the paramedics arrived and guided him towards the ambulance while waiting for the traffic police officers. Although injured, he refused to be sent to the hospital as he claims that he was alright. Shortly after the traffic police arrived, Officer Taufiq approached me and I gave him the recording of the SD Card, IC and Driving License. I was tasked to send the video clip to IO Vilton. While waiting, myself and the cyclist have exchanged contacts and personal information. Afterwards, the police officers gathered all of us and gave us a case card as well as to explain about the current situation and the follow-up. He advised me to make a police report within 24Hours. We were dismissed and I drove back home to make this current report
