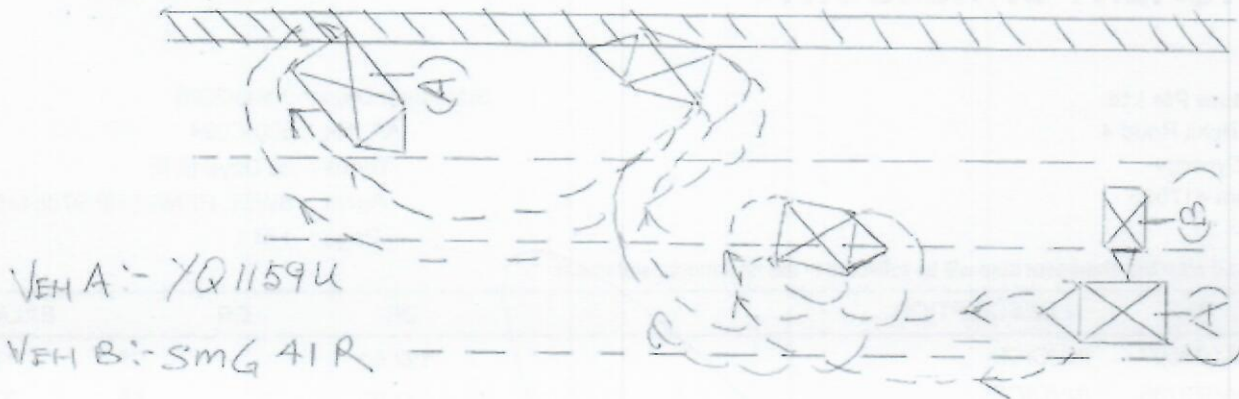

After the traffic police came, the officer took my particular and that is when I know from the in camera provider by the other car owner, the cause of the accident is when the blue colour vehicle (SMG41R) who was driving on the 1st lane lost control which causes him to drive toward my lorry and hit onto my fuel tank. A pieces of the car part was still on my fuel tank when i inspect the lorry.

I wish to state that i only went to the hospital the next day is because the injury got worst hence i went to see a doctor and was given 3 day mc.
