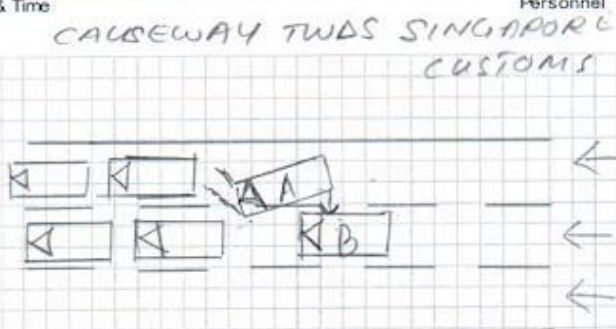

Describe Circumstances of the Accident

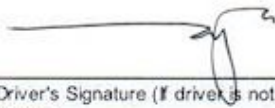
I was travelling from causeway towards Singapore Customs.

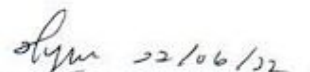
