CIRCUMSTANCES OF ACCIDENT

I WAS DRIVING ALONG ROBINSON ROAD AND STOPPED AT THE TRAFFIC LIGHT AT THE JUNCTION OF BOON TAT ST ON THE 4TH LANE. THE YELLOW TAXI SHC 7593 Z STOPPED ON THE 2ND LANE AT THE SAME TRAFFIC LIGHT. I MOVED OFF AFTER THE TRAFFIC LIGHT TURNED GREEN. AFTER SIGNALLING, CHECKING MY BLIND SPOT AND SLOWLY MOVING INTO THE 3RD LANE AT 25KM/H, BEFORE CROSS ST JUNCTION WHEN IT WAS CLEAR. SUDDENLY, THE TAXI SHC 7593 Z ON THE RIGHT SWERVED INTO MY LANE AT A FASTER SPEED AND HIT MY CAR. I COULD NOT STOP IN TIME AND WAS FORCED TO SWAY THE CAR BACK TO THE LEFT LANE DUE TO THE IMPACT.

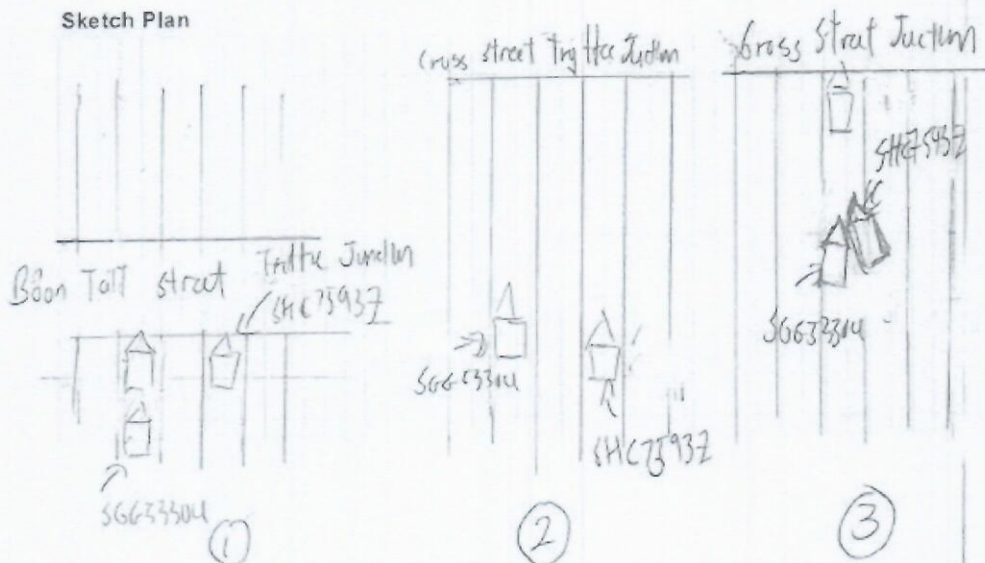

Describe Circumstances of the Accident


I was driving along Robinson Road and stopped at the traffic light at the junction of Boon Tat Street on the 4th lane. The yellow taxi SHC 75932 stopped on the 2nd lane at the same traffic light. I moved off after the traffic light turned green.


After signalling, checking my blind spot and slowly moving ~~off~~ into the 3rd lane at 25 km/hr, before Cross Street junction, when it was clear. Suddenly, the taxi SHC 75932 on the right swerved into my lane at a faster speed and hit my car. I could not stop in time and was forced to swerve the car back to the left lane due to the impact.
