Brief Details.

On 20/06/2022 at around 0648hrs, I was travelling along PIE headed towards Changi (around 4.4km mark). Suddenly I was hit from the rear, the collision caused me to fall off my motorcycle and on to the road. I looked up and realized that I was hit in the rear by a Blue, Comfort Taxi (SHA5220Z) landed and slid across the road for about two meters before stopping. My motorcycle was thrown a few meters further down the lane from where I was. I stood up and I moved to the road shoulder, the taxi driver (Mr Tan An Chye) and his three passengers came out of the car. The Taxi driver claimed that he did not see me on my motorbike which led to him colliding with me. He tried to leave the scene and told him to wait for Traffic Police which was called by one of his passengers. Ambulance also later came to scene, and I opted not to be conveyed by ambulance to the hospital. I suffered injuries of multiple abrasions around my body. I later went to Tan Tock Seng Hospital and was given 5 days of medical leave dated 20/06/2022 to 24/06/2022.

My motorcycle has multiple scratches all along the right side of the motorcycle and some scratches on the left side. My motorcycle was towed by EMAS to the nearest carpark, which I followed, before I went to Tan Tock Seng Hospital on my motorcycle.

Traffic Police and ambulance was at the scene. I do not have camera on my motorcycle or on my helmet. I am not sure if the Taxi has in-car camera. I am not sure if the Taxi driver or any of his passengers are injured, and I am not sure what damages the Taxi has, if any.
