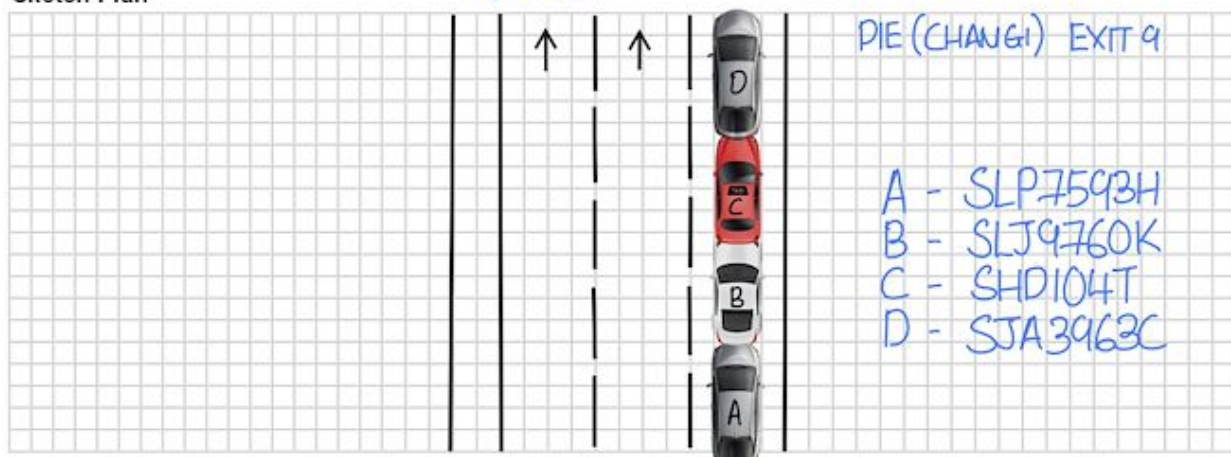

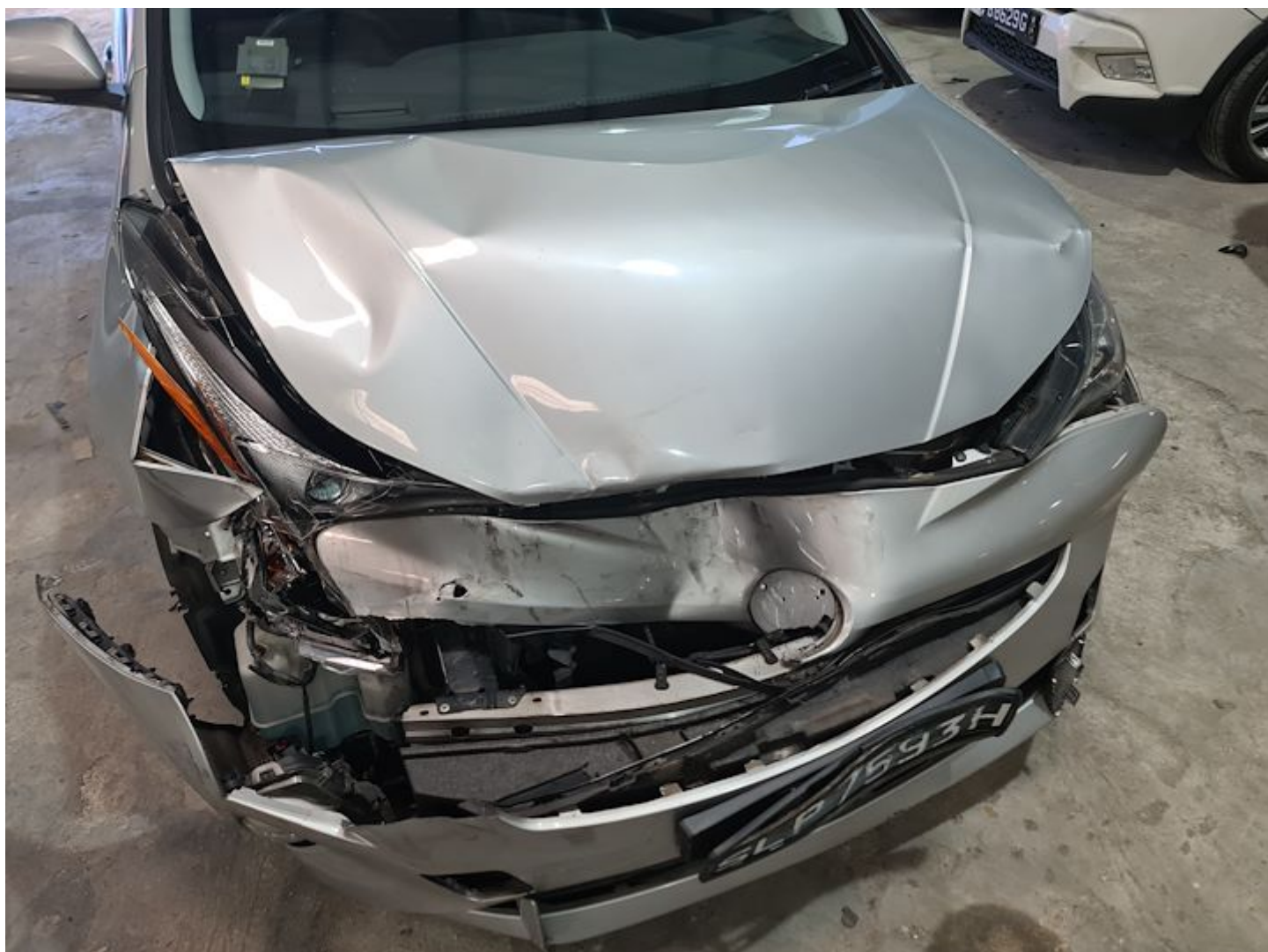

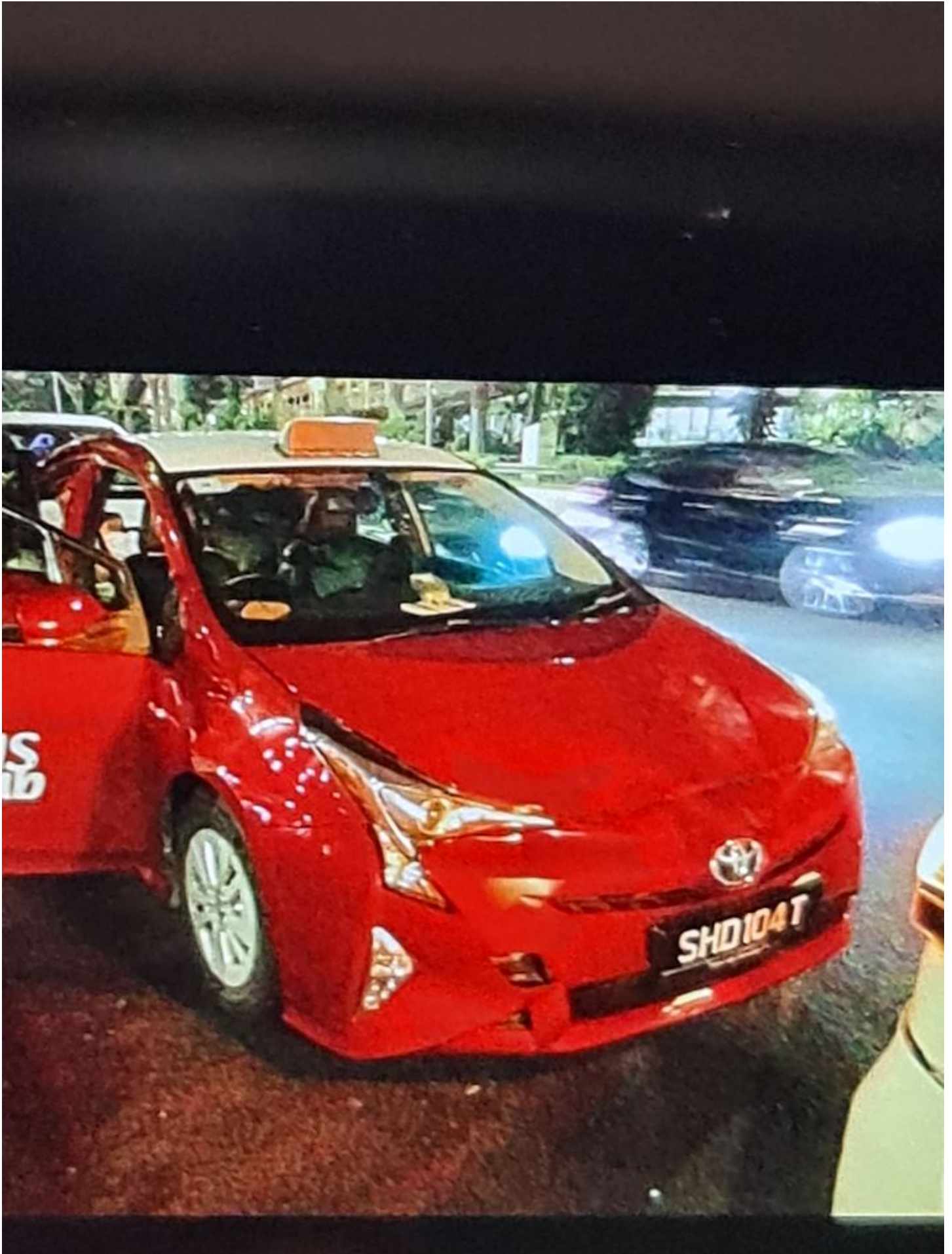

towards Bedok North Ave 3, with a Grab passenger, named Nurfahima Rahman.

There was no earning warning braking sign from the front vehicles, 15 seconds before the accident happened.

Just when i heard a loud bang sound, Nissan Qashqai, suddenly e braked and hit very hard at Transcab Taxi.

Immediately, i reacted and braked hard, at the same time tapping down the engine braking mode B, but still hit Nissan Qashqai, with front bonnet slightly squeeze under Nissan Qashqai.

Nissan Qashqai's front air bag was activated. There was a mild damage without any dent at the back of Nissan Qashqai.

According to Qahqai driver, Hor Kian Som, mobile number 83218155, he did not see any braking light along the way and could not stop on time when Transab Taxi hit Toyota Wish.

Both the back of Transab Taxi and the front of Nissan Qashqai was badly damaged.

The driver and passenger, from the Transab Taxi, were sent to the nearest hospital.
