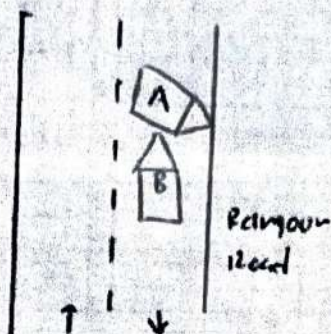

On 20/05/2022 at about 0430hrs I was driving my vehicle (SKU3271Z) along Rangoon Road. I made a U-turn along the said road. As I was about to make a U-turn on the 2-way lane, I saw a subject riding electric scooters on the opposite lane. I checked my blind spots on both left and right. I heard a siren coming from the back. As I was in the midst of making the U-turn, I saw a flashing blue and red light on my right coming from the direction of the lane I U-turned from. As I thought I was out of the way of any vehicle on the right lane. As my vehicle was in the left lane that I U-turned on, I looked to my right and sudden saw a white motorbike hit the back of my vehicle. I realized that I was involved in a road traffic accident with a traffic police officer was riding against the direction of the traffic flow thus the collision. I got out of the vehicle to check on the officer as he was lying on the road, within a minute a few traffic police officers arrived to my incident. I was informed by the officers that they were in pursuit of the few subjects earlier riding the electric scooters. The traffic police officer was attended to by paramedics. After the accident, I was instructed by the officers to lodge a police report.
