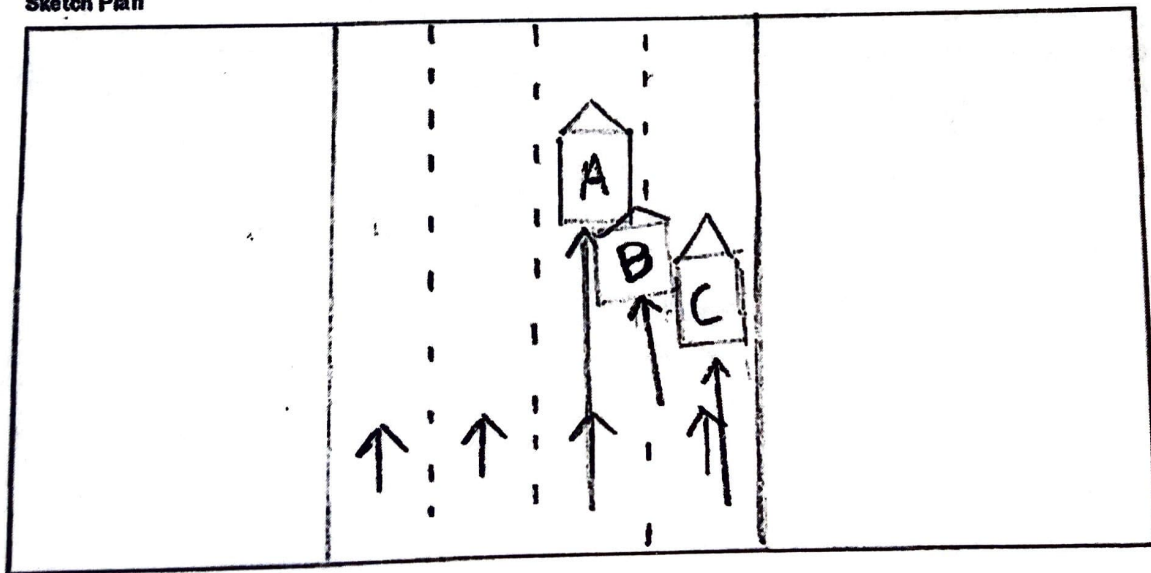
SKETCH PLAN
