1. There is no video. Only the pictures Steve Shaw took after the vehicles moved to stop blocking the road (attached). I have been thinking if it is possible to get that damage if Steve did what the other driver said he did – I don't think it is – the damage on the Camry at the point furthest forward impact point should have been much more significant, and less impact at the back, if he did cut across the truck, and Steve would have to have been willing to get himself (as driver, directly in front of the truck) and his passengers seriously injured to do such a manoeuvre.
