2 The Prime Mover collided onto the driver then rolled over the driver. The driver was then pronounced dead on the spot. The Prime Mover continued to roll towards a bollard and

stopped when it reached a metal railing.

3 It was observed that the Prime Mover engine was still running and the hand brake was disengaged when PO and IO arrived.
