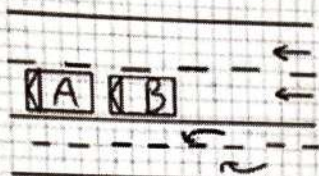

Brief Details

On 25 May, at around 12.31pm, my car was stationary under the overhead bridge at Bukit Timah Road, after the Newton Flyover towards Little India. A taxi (Car plate number: SHB 5025R) collided into the rear of my stationary car (SFH5000D). The sudden impact caused my lower back to hit against the seat and I could feel pain and numbness at my lower pain and neck region. I took a few minutes to regain my composure and the taxi driver told me to drive to the side to assess the damages. There were some scratches and dents at the lower back (metal and plastic regions) of my car. There were damages on the taxi front number plate. We exchanged contact numbers. The taxi driver declined to show me his NRIC, claiming that his taxi is a Singapore-registered vehicle and I have all the necessary information.

After the accident, I developed a headache and my lower back, upper shoulders and neck areas were rather sore. I proceeded to see a doctor. I was issued with 3 days MC and medication for my injuries. I have photos and a video (could not upload as size is greater than 2MB) of the accident.
