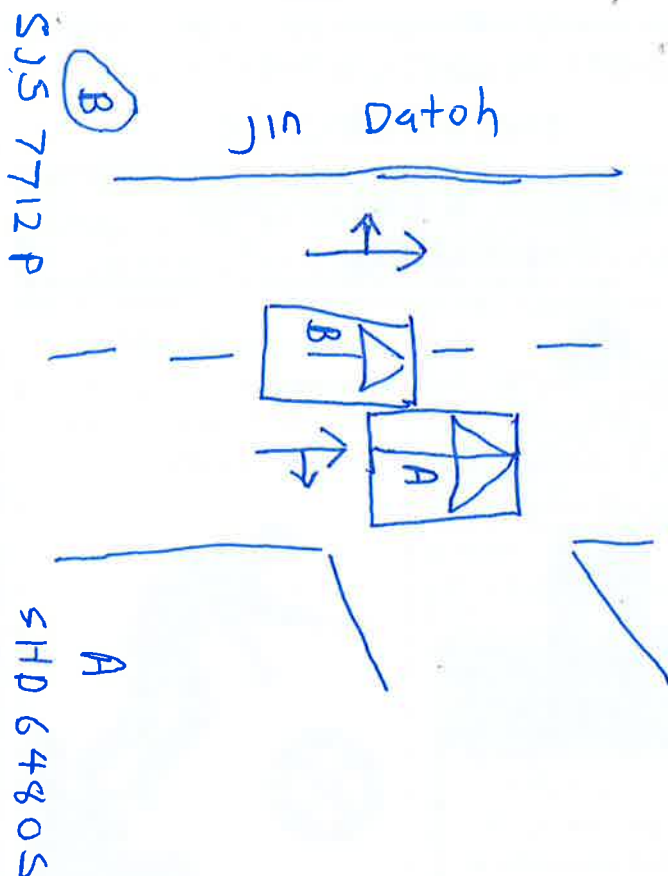

**Brief Details.**

On 29/06/2022 at about 1840hrs, I was driving (V1: SHD6480S) along Jalan Datoh with one passenger. I was on the most right lane, heading straight. Suddenly, (V2: SJS7712P) collided into the left side of my vehicle. The driver of V2 cut toward my lane as he wanted to make a right turn. Since I could not stop in time, it caused a long scratch on the left front side to the left rear side of my vehicle.

Both of us drivers got out and exchange particulars. My passenger also left as he was in a hurry. Since it was a minor accident, traffic police and ambulance was not called onto the scene. I reported the accident to my company after that.

On 29/06/2022 at about 2100hrs, I started feeling pain on my right side of my shoulder, neck and back area. I decided to go to the clinic the next day.

On 30/06/2022, I visited the clinic and was given 3 days MC dated from 30/06/2022 to 02/07/2022. The doctor just gave me medicines and advised me to go the hospital, if the pain persists.

I have a dashcam installed in my vehicle but it belongs to the company (Strides Taxi).
