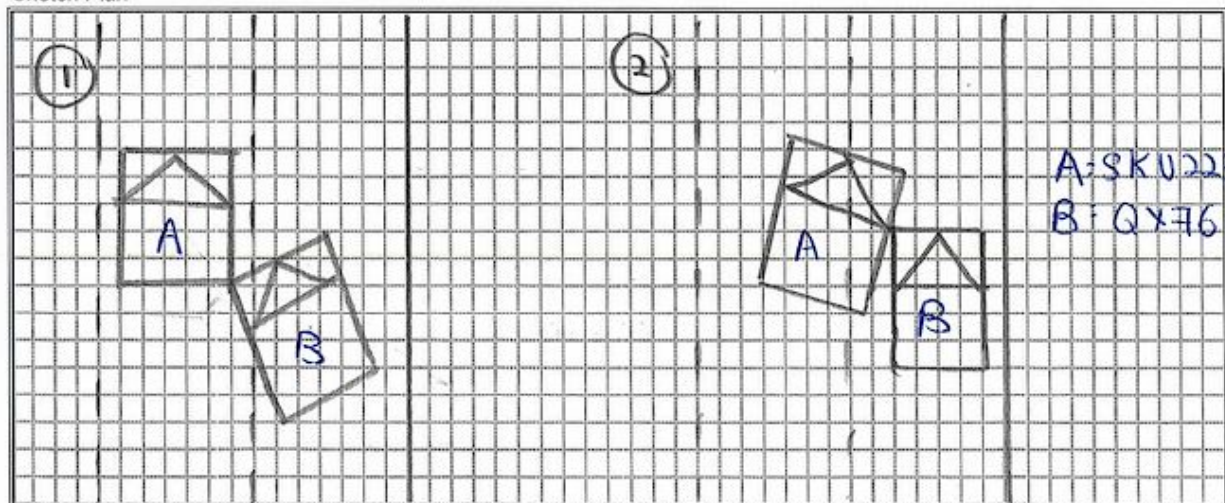

Brief Details.

On 28/06/2022 at about 1825hrs, I was driving my car bearing plate number SKU2231X on the PIE Expressway near to exit 16A. Subsequently, both our cars went opposite ways and my car came to a stop in between lane 3 and lane 4. I then came out of my car and the police officers came over from their vehicle to ask if I am okay. I also asked the female officer what had happened and she informed that the driver lost control of the car. After which, LTA officers, Traffic Police officers and the Ambulance arrived at scene.

I wish to state that I did not suffer any injuries. My car suffered scratches on the rear right side of the vehicle and scratches on the front right side of the vehicle with the top of the right side wheel part of the car slightly bent in.
