### THE ASSIGNMENT

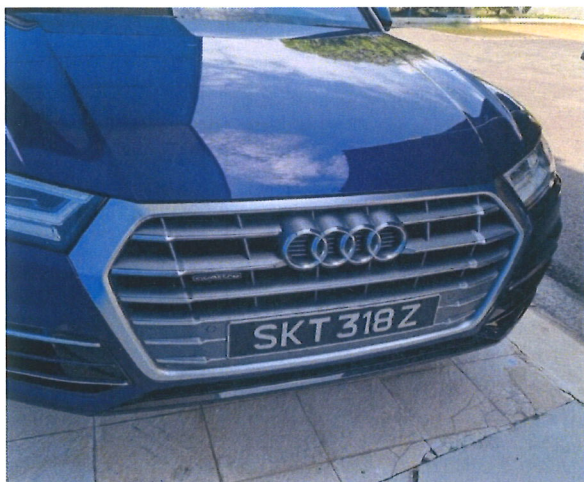
The survey was conducted at M/s. Glockewerke, 25, Kaki Bukit Road 4, Synergy@KB, #06-53, Singapore 417800.

### POINT OF IMPACT / ACCIDENT SCENE PHOTOGRAPHS

The vehicle sustained Left Hand Front portion damages during the accident on 18/04/2022. The Left Hand Front roadwheel was also affected.

It was report that the vehicle has been parked and subsequently hit by a lorry while reversing.

From the evidence of 9 pieces accident scene photographs and 4 pieces photos of video footage captured from the vehicle SKT318Z dashcam (*provided by the owner*), damages appeared consistent with the Police Report made.

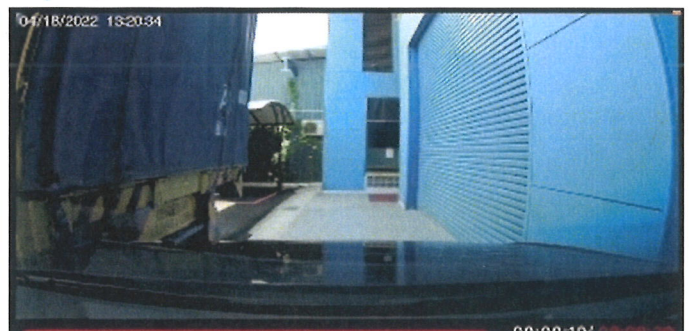

## DAMAGES / DAMAGED PARTS RECOMMENDATION

The bonnet, LHF fender, LHF fender top fledge cover and LHF aluminium rim were Dented / Distorted / Defaced.

*Other parts were also found damaged. (See schedule for details)*

Note: The bonnet and LHF wheel rim were made by aluminium material. Aluminium is unlike metal steel in that it doesn't have a "Memory Metal". It cannot be reshaped back to its undamaged state as easily as steel even though trying to perform welding and panel beating. Especially the surface are badly Dented/Distorted and/or brushed chrome surface was Defaced. Therefore, we recommended to be replace.

## PART-BY-PART / LUMP SUM REPAIRS RECOMMENDATION

The used parts for this model were not available. Beside, the vehicle is only about 2 years and 10 months old. And it is still under warranty by Agent of Premium Automobiles. In our opinion, it is fair and reasonable for Part-by-Part Repairs Basis to re-instate/revert the vehicle back to its road-worthy / pre-accident condition.

## ADJUSTMENT RECOMMENDATION

We have inspected thoroughly each and every item on the repairer's estimate against the actual damaged found on the vehicle. We list the breakdown of our findings and our recommendation as per schedule attached.

Our adjusted amount for the cost of repairs is SGD \$8,828.10.

## CONCLUSION

The repairer has agreed to undertake repairs at our adjusted amount of SGD \$8,828.10 corresponding to labour charges, spray painting and replacement of parts.

This inspection was conducted entirely on a 'Without Prejudice' basis. We have not given an authorization and/or instruction to the repairer to proceed with the repairs.


