VEHICLE B WAS TRAVELLING IN FRONT OF VEHICLE A. VEHICLE A WAS CHECKING FOR ONCOMING VEHICLE ALONG MAJOR ROAD BUT DID NOT REALIZED THAT VEHICLE B WAS STATIONERY AT THE GIVE WAY LINE. EVENTUALLY VEHICLE A COLLIDED ONTO REAR OF VEHICLE B. NOBODY WAS INJURED AT THE TIME OF ACCIDENT.

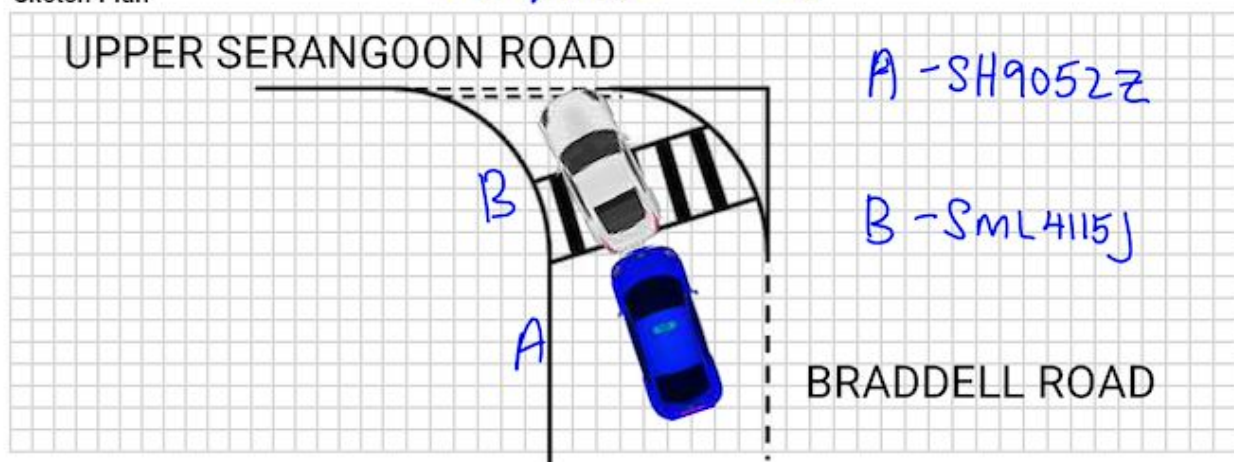
