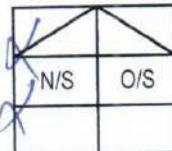

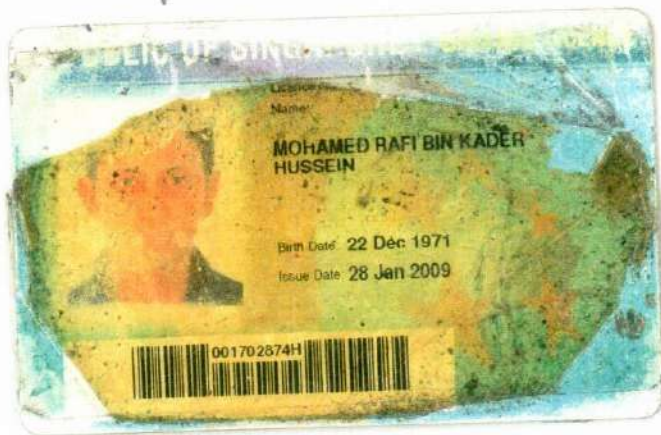

Brief Details.

On 19/06/22 at about 10.26am, I was riding my motorcycle along Sims Ave near the junction of Lorong 11 Geylang and going straight down the road. I was on the extreme right lane while riding on my motorcycle. I noticed that there was a Lorry beside me which had its right signal on and wanted to make a right turn into Lorong 11 Geylang. As I was riding straight down past the junction of Lorong 11 Geylang, the said Lorry had suddenly make a right turn and collided into my motorcycle. Due to the impact of the collision, I fell off my motorcycle and landed on the road. I was conscious at that point of time and one of the passersby assisted to call the ambulance for me. Shortly, the ambulance came and I was being conveyed to Tan Tock Seng hospital.

At the hospital, the doctors examined my injuries and also took a x-ray. Through the x-ray, it showed that I did not suffer any fractured bones. However, I felt pain on my chest, ribcage, and back area. There were bruises on my left knee and ankle. I was kept under observation at the hospital for ten days before I was discharged on 29/06/22. I was given 16 days hospitalization leave.

During my stay at the hospital, the TP IO contacted me and advised me to lodge an accident report regarding the matter once I was discharge from the hospital. The incident number given to me was G/20220619/0158.

My motorcycle was installed with dashcam at the front and back of my vehicle which captured the accident. From the accident, there was scratches on the front tire of my motorcycle. I am unsure of the estimated cost of damage. I am unsure to provide the details of the Lorry that was involved in the accident.
