**Brief Details.**

On 28.06.2022, at about 0820hrs, I received a call from the number HP: 6557 5356 Suhana however, I was unsure which department she was calling from. According to Suhana, she informed that on 27.06.2022, during late night, there was an ambulance making a 3 point turn and the ambulance bearing reg no QX1692T accidentally hit onto my stationary motorbike bearing reg no FBJ4483L that was parked at the open space carpark KB11, lot 110. Suhana further revealed that there were members of public who assisted to shift my bike to its original place.

I then proceeded to make a check on my motorbike and noticed that there was a Singapore Civil Defence Force note left on my motorbike. The content of the note was to notify the owner that there was an accident involving SCDF vehicles. At the back of the note, there was a written apologies stating that it was Sgt3 Adam from Kallang Fire Station HP:91690417 who hit onto my vehicle.

I wish to state that as of now, the damages I could see on my vehicle was that the left brake lever was broken, right mirror was partially broken, left mirror was broken, and the engine sound seems to be different. I will be sending the motorbike to the workshop for a detailed damage report for SCDF follow up. As my brother namely Mohamad Dzulhimi Bin Ramli HP:85007762 is the second rider and mostly riding the motorbike, I will be authorizing him to do the follow up with SCDF.




