ON 30/06/2022 AT ABOUT 0930HRS, I WAS TRAVELLING ON THE 3RD LANE IN VEHICLE A BEARING VEHICLE REGISTRATION PLATE, SHD4517J, ALONG GILLMAN FLYOVER FROM ALEXANDRA ROAD TOWARDS PASIR PANJANG. AS I WAS APPROACHING ALEXANDRA ROAD, ANOTHER VEHICLE IN FRONT OF ME SUDDEN JAMMED BRAKE CAUSING VEHICLE A TO REACT AND APPLIED BRAKES. VEHICLE B WAS UNABLE TO STOP ON TIME AND REAR ENDED VEHICLE A LEFT REAR SIDE. BOTH DRIVER AND PASSENGERS IN VEHICLE A SUSTAINED NECK AND BACK INJURY. THE PASSENGER IN VEHICLE B MAY BE INJURED. 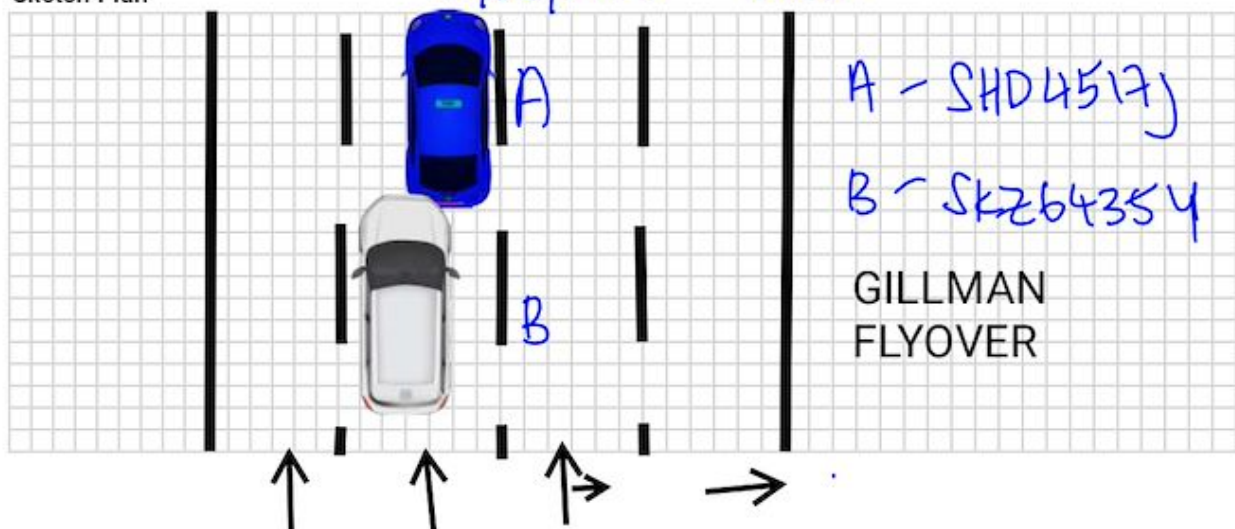

ON 30/06/2022 AT ABOUT 0930HRS, I WAS TRAVELLING ON THE 3RD LANE IN VEHICLE A BEARING VEHICLE REGISTRATION PLATE, SHD4517J, ALONG GILLMAN FLYOVER FROM ALEXANDRA ROAD TOWARDS PASIR PANJANG.
