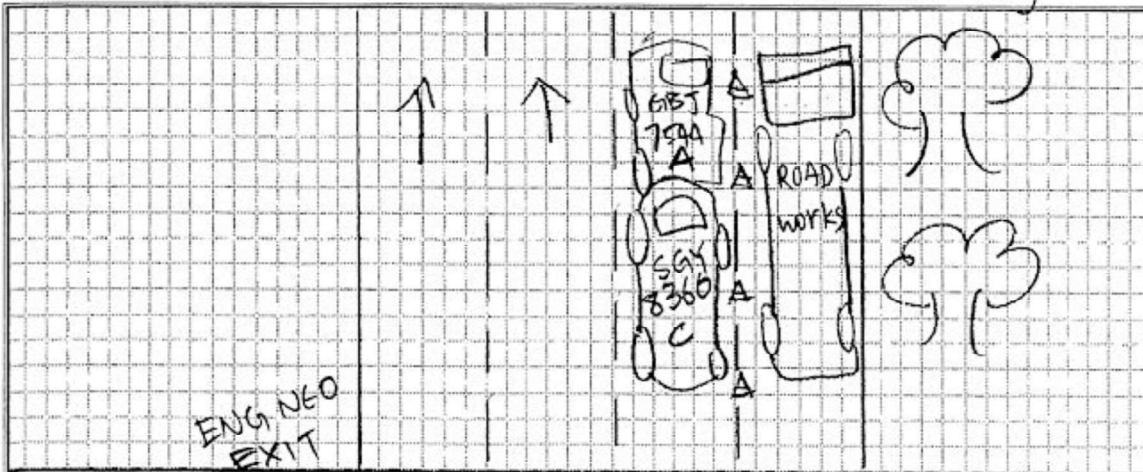



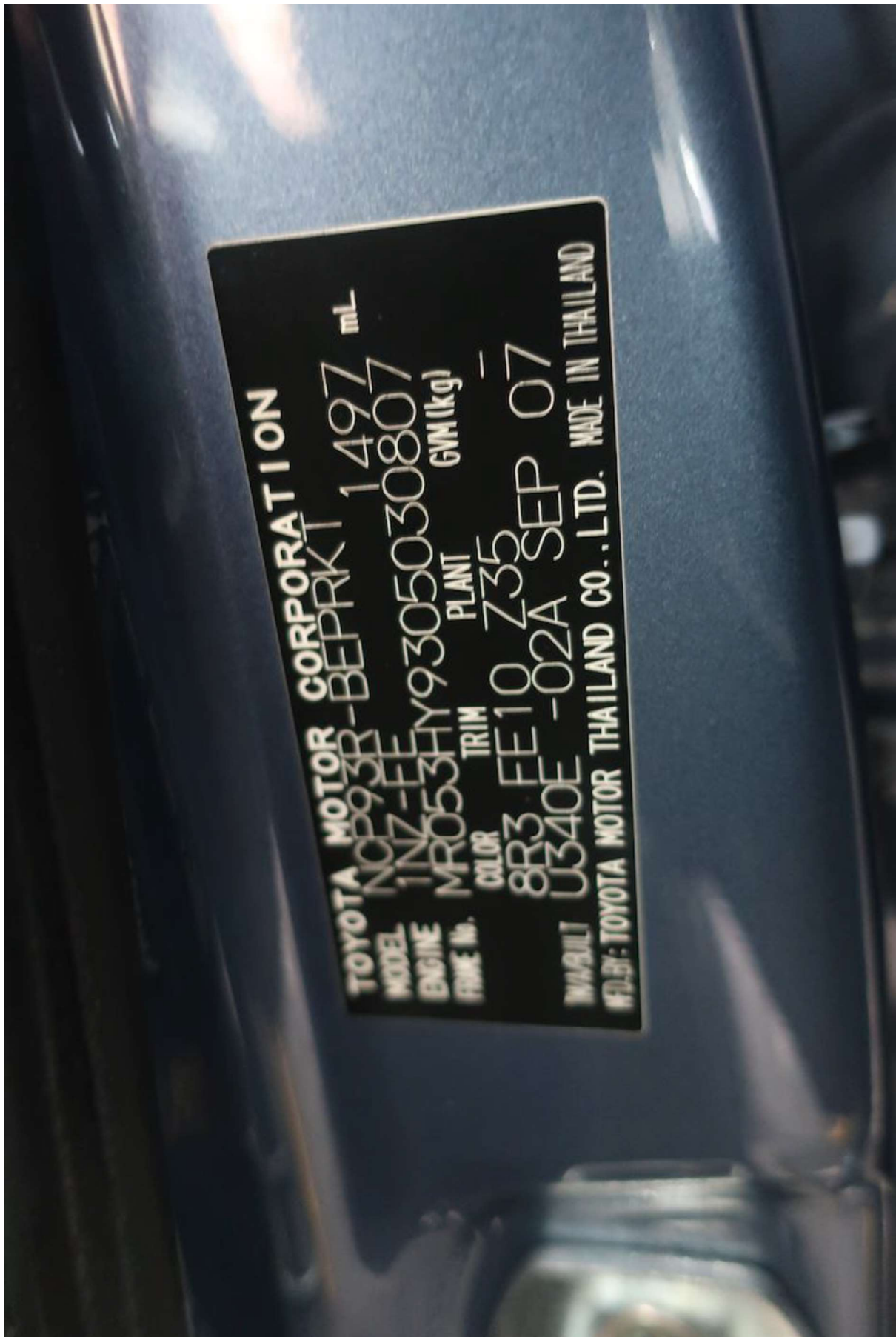

NOTICE OF REPORTING

This is to confirm that Wong Wei Hao, Douglas, NRIC: S9036123F, has reported to the Police a non-injury traffic accident which occurred along PIE on 10/07/2022 at about 1420hrs involving the following vehicles: SGY8366C & GBJ7544A

On 10/07/2022 at about 1420hrs, I was driving my company's vehicle bearing plate number SGY8366C along PIE towards the direction of Tuas. As I was driving along Lane 2 (near to exit of Eng Neo), a vehicle (GBJ7544A) travelling in front of me came to a sudden stop. I had immediately jammed the brakes but could not stop in time. The front of my vehicle had collided onto the rear of the said vehicle.

Both the driver (Li Linwang, S7176439G, 96867257) and I had alighted to assess the accident. We had spoken to one another and also exchanged particulars. No one suffered any injuries. Other road users were not involved, and no Government property was damaged. No assault or threat took place as well. There is an in-car camera installed at the front of my company's vehicle.
