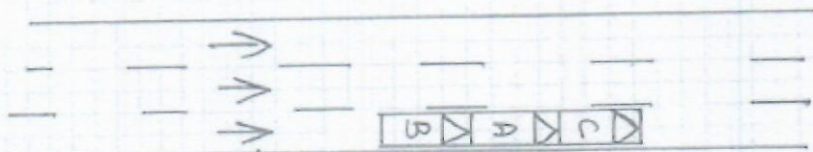

P1E towards Changi after Steven Road Exit.


Describe Circumstances of the Accident
