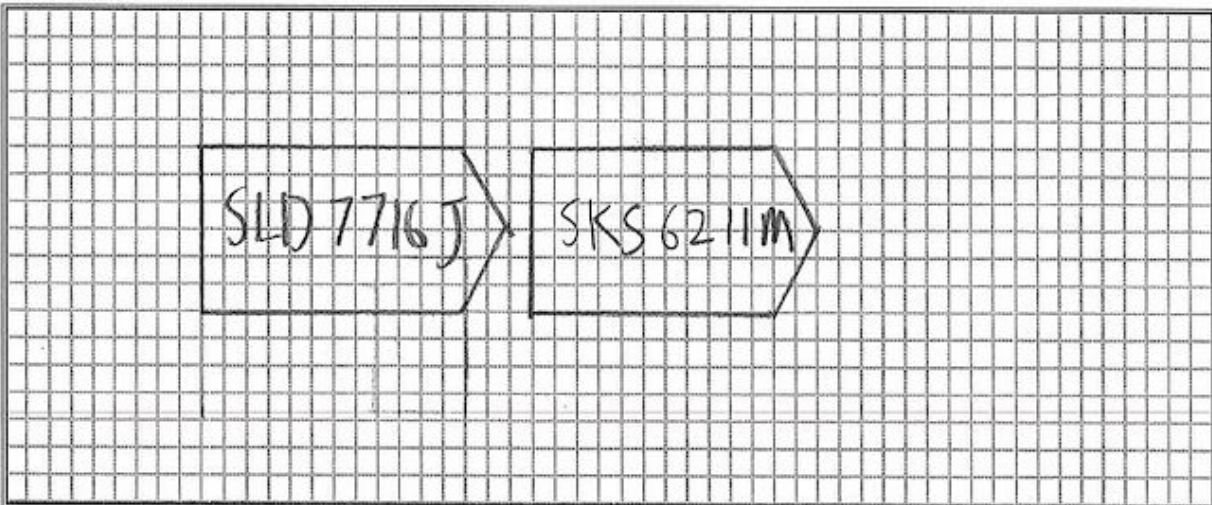

**Sketch Plan**






I was driving along the CTE. The vehicle SKS 6211M jammed its breaks. I jammed my breaks as well but hit the vehicle.



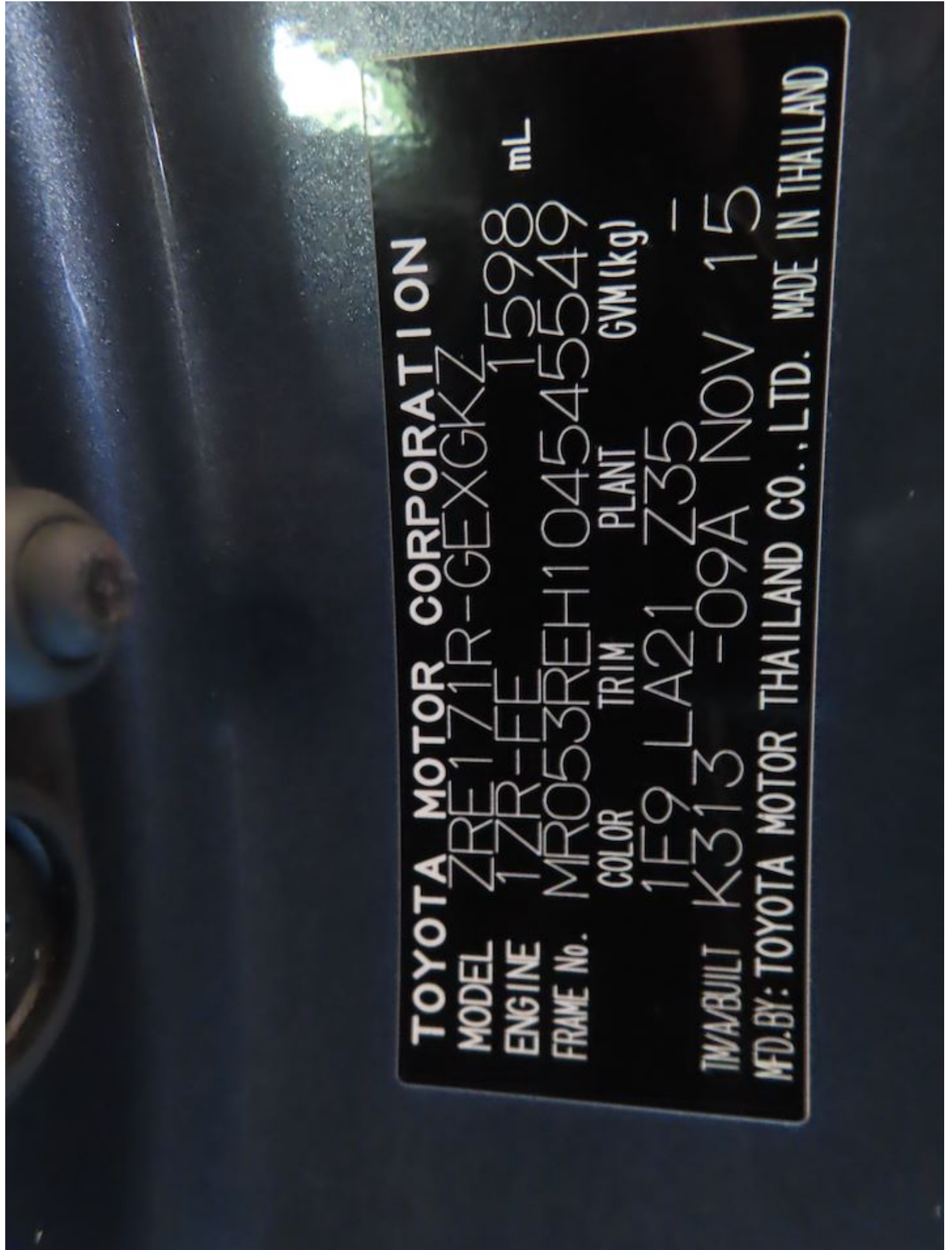
