



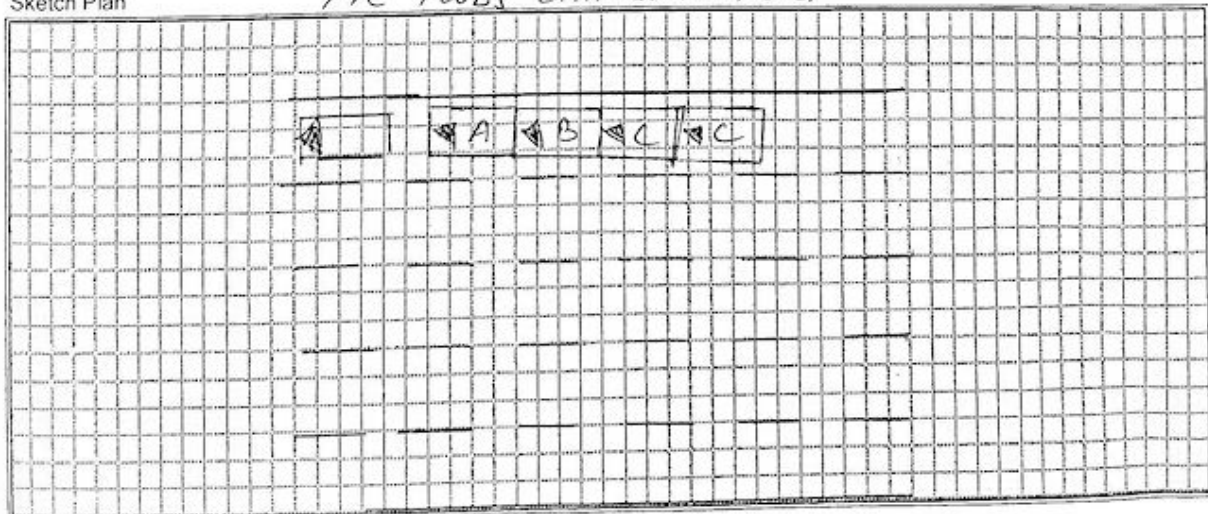

A - S4M7770M C - SLX2682A



Describe Circumstance of the Accident


