1. The accident has affected 2 panels (rear bumper and Tailgate). The \$1500 coating is for whole car. We will recommend for two panels only (with consideration that the whole car has a total of 12 panels such as Front Bumper, Front LH & RH Fender, Front LH & RH Door, Rear LH & RH Door, Rear LH & RH Fender, Rear Bumper, Tailgate, Roof panel)
2. The market rate based on the actual coating price did earlier of 2022 is \$1588 for whole car (12 panels), thus we recommend an amount of \$132 per panel, totaling of \$265 for 2 panels. However, please note that every shop has different pricing and it may vary from one shop to another.
